<u>Festival/Event:</u> The 2023 Juneteenth Celebration is scheduled to be held June 16-18, which includes a Food Truck event on Friday, June 16, the Juneteenth Festival on Saturday, June 17 and a brunch on Sunday, June 18.

<u>Bluffton Event:</u> Burnt Church Distillery is the site for all weekend events.

<u>Tourism Draw %</u>: The 2022 event drew over 10,000 tourists with more than 40% being tourists from Savannah, Charleston, Charlotte, South Florida, California, Baltimore and The Canary Islands.

<u>Benefit to Tourism</u>: Because this is marketed as a weekend-long event, Bluffton benefits from hotel stays and increased visitors to local shops and restaurants. For 2022, revenue brought to Bluffton is estimated to be \$150,000.

<u>Self-Sufficiency % (Financial Need)</u>: Eligible amount requested is 40% of the total budget. Additional anticipated revenue will come from Burnt Church Distillery donations, including some in-kind services, as well as other corporate and foundation sponsorships.
