



- o Daria Shenefield aka Daria Sperzel called complaining again regarding Robin the Builder and Adam Goldstein builder having no license. Turns out they are licensed, and the complainant has issues previously and is dealing with Richard Spruce from the building department.
- o Daria was referred to Richard Spruce as Codes not getting involved due to Richards ongoing matter with her and her issues.
- o Business Letters regarding Late on Renewals are now being drafted for 347 businesses.
- o Grooby's Too Restaurant was issued a NOV, but 2 days later complied and removed her flags.
