Approval to Authorize a Design-Build Contract with Carolina PROJECT: Recreation and Design, LLC for the Oscar Frazier Splash Pad (Fiscal Impact: \$750,240.39)

**REQUEST:** Staff requests that Town Council authorize the Town Manager to execute a Contract (Attachment 2) with Carolina Recreation and Design, LLC to provide design and construction services for the Oscar Frazier Splash Pad Project in the amount of \$655,231.45. In addition, Staff requests a 15% contingency allowance of \$95,008.94 to cover any unforeseen circumstances that may arise during construction for a total fiscal impact of \$750,240.39.

The total contract amount is within the approved budget limits established with the Adopted Consolidated Municipal Budget for Fiscal Year (FY) 2024 and illustrated on the attached Data Sheet (Attachment 3).

**BACKGROUND:** The contract will include design, construction documents development, and construction of the Oscar Frazier Splash Pad Project, located directly south of the existing restroom pavilion. This portion of the project consists of an approximately 2,200 square foot recirculating splash pad with 23 spray features, associated piping, water wise controller and poured in place rubber surfacing.

Staff requested proposals for the design, purchase, and installation of a splash pad and received three responses to the RFP posting. A formal review and selection team was formed and determined Carolina Recreation and Design, LLC to have the best combination of design and experience for this project (Attachment 4).
