<u>Advertising:</u> Approximately 71% of requested funds will be spent on advertising/marketing, which will include banners and signage, postcard mailers, social media posts, and apparel and take away gifts that include the Bluffton Heart of the Lowcountry logo.

<u>Festival/Event</u>: To be held on the evening of December 24, 2023

Bluffton Event: This year's location is Oyster Factory Park

<u>Tourism Draw %</u>: This is a first-time event and tourism statistics have not been gathered in the past.

<u>Benefit to Tourism</u>: Folks from Jasper, Hampton, and Colleton Counties have historically attended. The event is also livestreamed to promote Bluffton and generate interest in and travel to the community.

<u>Self-Sufficiency % (Financial Need)</u>: The request is around 77% of the total budget, with approximately 71% going towards marketing and promotion. In-kind services of volunteer hours as well as donated goods also contribute to the event.
