BACKGROUND:

In accordance with the grant process, the Accommodations Tax Advisory Committee (ATAC) held a meeting on November 15, 2023 to review the quarterly applications. There were five (5) applications to review and make recommendations of funding to Town Council.

ATAC voted and unanimously approved Sam Britt to Vicechair and approved the 2024 calendar.

Additionally, staff provided an overview of the legal opinion pertaining to Local ATax and has incorporated ATAC into the Town budget calendar. Staff will present a draft of the FY2025 budget to ATAC at the February 20, 2024 meeting.

Funds Currently Available for Distribution:

When comparing the State Accommodations Tax collections for the quarter ending September 2023 to the same quarter of last year, the revenues are down \$19,894.73 or approximately 7.8%.

Total estimated State Accommodations Tax funds currently available for distribution are \$152,166 as outlined in the following chart:

Funds Requested for Distribution:

- ☐ The New Bluffton Worship is requesting \$23,110 in support of the Christmas Under the Stars Project with ATAC recommending \$15,280.
 - The total budget for the project is \$29,830 with approximately 51% or \$15,280 being requested.
 - Project costs requesting support or for advertising, rentals for stage, tent, and chairs, and for security services through the Bluffton Police Department.
 - Advertising include banners, postcard mailers, social media posts, and signage.
 - The event will be held at Oyster Factory Park the evening of December 24, 2023.

The committee voted 5-0 to recommend a total award of \$15,280 presented in the chart below:

- ☐ Gullah Traveling Theater, Inc. is requesting \$18,791 to support advertising and promotion of tourism and facilities for cultural events for Gullah Kinfolk Come to Bluffton.
 - There currently is not a schedule of events in Bluffton.
 - ATAC recommends the organization come back and reapply when a schedule is finalized with dates, times, and locations.

The committee voted unanimously to not recommend any funding at this time and for the organization to reapply when a schedule is complete.

- ☐ May River Theatre, Inc. requests \$39,801 to support advertising and promotion expenses for the 2024 season.
 - The total budget for the project is \$98,726 with approximately 40% or \$39,801 being requested.
 - There are six (6) performances scheduled for the 2024 season. Calendar Girls (February/March), Jesus Christ Superstar (April), Lend Me a Tenor (June), Series of One Acts (August), Carrie (October/November), and Holiday Show (December).
 - Average attendees for the 2023 season show approximately 40% are from out of town.
 - Eligible "tourism-related expenditures" include:
 - "Advertising and promotion of tourism" requesting \$27,022 for newspapers, magazines, social media, billboards, and creation of posters and rack cards.
 - "Facilities for Civic & Cultural Events" requesting \$12,779 for royalties for each show.

The committee voted unanimously to recommend a total award of \$39,801 presented in the chart below:

- ☐ Farmers Market of Bluffton requests \$55,300 to support advertising and promotion of tourism and facility support for the weekly Farmers Markets.
 - The total budget for the project is \$138,850 with approximately 40% or \$55,300 being requested.
 - The Markets are held every Thursday from January 11, 2024 through December 19, 2024 at Martin Family Park.
 - Eligible "tourism-related expenditures" include:
 - "Advertising and promotion of tourism" requesting \$42,800 for newspaper, magazines, social media, newsletter, and text alerts expenses.
 - "Facilities for Civic & Cultural Events" requesting \$12,500 in support for market overflow rental fees at the Heyward House, tents, chairs, safety signage, and other expenses to facilitate the markets for visitors to safely enjoy.

The committee voted unanimously to recommend a total award of \$55,300 as presented in the chart below:
