The Juneteenth events, scheduled for June 6th-June 15th throughout the Town of Bluffton will celebrate the abolishment of slavery recognized by the Emancipation Proclamation which declared all enslaved Africans to be free and considered American citizens and human beings deserving of life liberty and the pursuit of happiness.
