Police Initiatives:

- Community Connections Program Command Staff and Patrol Officers teamed up to visit area businesses. This project will be on-going. We have received many positive responses internally and externally.
- Multi-Jurisdictional Hiring Expo All area law enforcement agencies are combining their recruitment efforts and holding a Lowcountry law enforcement hiring event. All area agencies have committed to participate in a condensed area event including physical agility testing and written exam. Participating agencies will showcase the highlights and benefits of their individual agency. This is an innovative solution to staff not only Bluffton Police, but combat the recruiting and retention crisis within Law Enforcement. This has been postponed until September due to logistics.
- Less-Lethal Training Officers and Sergeants have received bean bag certification and re-certification to provide less-lethal options for volatile scenarios. We are currently ensuring all field sergeants have this capability and are certified in the use of bean-bag munitions.
- Crisis Intervention Training Officers attended Crisis Intervention training which is a top priority. Bluffton Police Departments goal of 50% of operational personnel trained in CIT will be completed by the end of 2021.
- TI Simulator provides officers with a highly inter-active learning experience. It enables instructors to control scenarios based on officer's responses. And it provides real time feedback while simultaneously controlling the learning environment. This innovation allows officers to practice de-escalation techniques while reviewing departmental policies and law enforcement best practices

TOWN OF BLUFFTON LAW ENFORCEMENT CITIZENS ADVISORY COMMITTEE MEETING Thursday, May 13, 2021

Chairman Tabor Vaux called the meeting to order at 6:04 p.m. followed by the Pledge of Allegiance.

A motion to amend the minutes from April was presented and Jennifer Morrow seconded the motion.

Old Business:

There was not any "old" business that needed to be addresses.

New Business

- It was brought up that Rosette El Sahlani is no longer an active member of the committee and that the committee will be looking to replace her position in the near future.
- Lawrence Ruocco stated that due to personal reasons that he will no longer be available to serve on the committee. A motion was made to move the meeting to a different day to accommodate Lawrence Ruocco's schedule however, Mr. Ruocco advised that he would not be available any day throughout the week.

Bluffton Police Department Update:

Captain Chandler provided the committee with an update on the status of the Bluffton Police Department.

- Bike day was held at River Ridge Academy and Officers provided safe travels for children riding their bicycles to and from school. Officers targeted high traffic areas and provided motivation and safe travels to all pedestrians.
- "Tweet Along" The department's PIO implemented a new program called "Tweet Along" where she conducts a ride-along with an officer. The PIO rode with one member of the Traffic Unit and their focus was conducting traffic control within several school zones within the jurisdiction. Several traffic stops were conducted on Buckwalter Pkwy and HE MCCracken during the morning school zone activation.
- Officers provided traffic control for the Home and Garden event located behind Southern Barrel.
- Officers provided traffic control for the May Day 5K.
- Officers provided assistance for a local Boy Scout troop for the collection of worn and tattered American Flags.
- May 22, 2021 there will be a safety day held on the side parking lot near the Oyster Factory on Wharf Street.
- Boat Patrol will commence operations on Memorial Day weekend and throughout the summer.
- Cookout with the Cops event will be held at the Baynard Park community on June 11, 2021. Time of the event will be determined at a later date.
- The department currently has one officer on FTO and one graduating the academy on Friday. There
 has been four offers sent out to qualified applicants. There will be additional offers sent in June.

- School is ending soon and all of the SRO will be temporarily re-assigned positions to augment patrol and other divisions.

Discussion:

- Michael Frazier stated that he was present during the Bike Day and he stated that the public really appreciated having officers present to provide safety for the children.
- A question was presented in reference to speeding on Fording Island Rd. Captain Chandler responded with that the department is actively conducting research in speed reduction methods. Captain Chandler stated that there might be some environmental additions that may be implemented such as additional signs, etc... Captain Chandler stated that the department is looking at possibly adding a motorcycle unit. Captain Chandler stated that the speeding is a "Human nature issue," and that as long as people continue to drive on Fording Island Rd we will continue to have people speeding. Officers continue to enforce traffic violations.
- Lawrence Ruocco asked if there was a way to place additional "parking pads" where Officers have a safe place to run stationary RADAR. Captain Chandler stated that he will look into it however, there are many factors involved. Jurisdiction is one factor that creates an issue as well as ownership. For example, certain roads are state, county, and city jurisdiction and each has a unique set of rules.
- A question was asked about the gender and ethnicity of the applicants who received an offer. Captain Chandler stated that at least one female received an offer and that her ethnicity is Hispanic.
- Captain Chandler also stated that the BPD is currently in the process of reviewing several policies within the BPD SOP. These policies have been reviewed by a policy review committee. Once each policy has been reviewed, it is sent to the Chief of Police for final review. Once the Chief reviews and approves the updated policy it is then sent to the town lawyer and then to council.
- Jennifer Morrow asked about the current issues in regards to policing on the National level and how that effects the BPD. Captain Chandler answered that the BPD continues to monitor issues on the National level and states that the BPD has already mandated policies such as "duty to intervene" before this issue was identified on the National level. Captain Chandler emphasizes that education among the department is of high priority and that implementation of policy review is necessary to address changes in the law and changes on procedures.
- Captain Chandler stated that the simulator may be up and operational possibly in July and that he will notify council and invite them to observe the advantages of having this useful equipment.
- Larry Ruocco asked the question about if there is anything in place to help educate the citizens on proper "behavior" while on a traffic stop. Captain Chandler stated that young drivers are being educated by the SRO at the high school level. Larry suggested that perhaps the information could be given to local driving schools as well.

A motion to adjourn was made at 1833 and several members seconded the motion.







COVID-19 Pandemic Calls for Service Comparison Charts






