Please find the documents enclosed for the Amendment #3 submittal for the and 54 Bridge Street project. Below is a description the exterior changes to the drawings. Changes to the drawings are clouded with a revision bubble. In order to comply with the rating requirements for the electrical service panels below the egress stair, we added a fire rated partition between the panels and the stairs, to match the exterior detailing. On the other side of the panels is a 6' louvered fence to match the approved fence details from 54 Bridge Street. We added a fire rated ceiling to the bottom of the stair landing above the electrical panels.

#### 54 Bridge Street (Building 3) Sheets submitted:

- East Elevation: 3 piece Hardie trim band at porch that covers the added thickness for the ceiling added to the bottom of stair landing. Window on the second floor at the right side of the elevation has been added back that was in the original approved submittal, and removed in HPC Amendment #2.
- <u>Enlarged Floor Plan and Partial Elevations</u>: 6' high fencing added to screen electrical panel at South Elevation, matching approved service yard fence details. Partial North elevation shows new exterior wall with 3" exposure Hardie siding, matching existing exterior detailing.
- <u>Detail Sheet</u>: Section through ceiling shows the added fire rated ceiling assembly, and new 6' louvered fence. Rated partition wall detail shows new wall with 3" exposure Hardie Lap siding, trim band and concrete curb below. Ceiling detail shows the enlarged details of the trim and ceiling assembly.



2 PARTIAL FLOOR PLAN 1/4" = 1'-0"






PARTIAL SOUTH ELEVATION 1/4" = 1'-0"


APPROX. ELECTRICAL PANEL LOCATION


