3. Town Investment Portfolio Update - First Citizens Wealth,

Neil Chapman, Senior Portfolio Strategist and Grant Catoe, Institutional Consultant

Neil Chapman, Senior Portfolio Strategist and Grant Catoe, Institutional Consultant representing First Citizens Wealth provided a comprehensive review of the Town of Bluffton's Investment Portfolio.

## VI. PUBLIC COMMENT

<u>Andera Pressley 21 Pinecrest Way</u> - Ms. Pressley addressed council regarding the traffic impact associated with the possible development of the Pinecrest golf course.

<u>David Cowart 23 Pinecrest Way</u> - Mr. Coward addressed council to advise and share concerns of the development plan in Pinecrest that will affect the community, school safety and traffic. He also referenced rumors circulating within the community via various social media platforms.

<u>Zeke Jordan 3792 Okatie Hwy</u> - Mr. Jordan addressed council in opposition of the New Riverside Linear Trail Project.

<u>Skylar Jewell 27 Pioneer Point</u> - Mr. Jewell address council regarding the New Riverside Linear Trail Project. He expressed concerns regarding the impact on wildlife and offered alternative locations for recreational space in Bluffton.

<u>Former Mayor Emmett McCracken</u> - Mr. McCracken addressed council regarding the appointment of Walter Nester III to the Military Enhancement Committee. He made the recommendation in support of the Resolution to appoint Mr. Nester to the committee.

<u>Laura Sterling 113 Foreman Hill Road</u> - Ms. Sterling addressed council in opposition to the New Riverside Linear Trail Project. She read a letter from a community member and presented pictures for council to review.

<u>Kim Konte 90 Big Bluff Rd</u> - Ms. Konte spoke of the Non-Toxic Neighborhood program supporting organic landscape management. She has requested adopting further safeguards for our community and assisting in spreading awareness to the Senate.

# VII. COMMUNICATIONS FROM MAYOR AND COUNCIL

Mayor Pro-Tempore Wood — Commended town staff as well as town manager for the success of the festivities of the 4th of July Fireworks and Independence Day Celebration. All the events that are held throughout the town are what having a sense of community is. A recommendation was made to the mayor and council to move the Communications from Mayor and Council ahead of the Public Comment session in the future due to many individuals exiting Council Chambers after the Public Comment period had closed.

**Councilmember Hamilton** – Mr. Hamilton advised he does not normally respond to public comments made; however, he had decided to respond this evening. He stated, Nextdoor, Facebook, and other social media platforms have turned into an outlet for anyone who is having a bad day to use. He addressed the individual that shared the rumors being shared during his time of public comment, advising they are not true.

**Councilmember Burden** – Mrs. Burden also addressed individual regarding the rumors, stating her opinion has not changed. She then requested Heather Colin, Assistant Town Manager provide a detailed timeline associated with New River Linear Trail dating back to the June 2000 as part of the Jones Estate Development Agreement.

Heather Colin provided the following outline:

The New River Trail Master Plan was established in 2003.

The Trail Deed Conveyance to the Town occurred 4/11/2005.

Permitting CZC, DHEC, MS4 and other permitting for the current project occurred 11/2024 Phases 1 and 3/2025 Phase 2.

Contract 2025-53 to Nix Construction was awarded - 6/2025 to include the scope of a 10' path along trail, covered pier at New River, reconstruction of three trail bridges.

**Funding Sources Grants:** 

2011 New River Trailhead development project SC PRT grant reimbursement \$85,726

2023 New River Trail Restroom \$26,000

2024 Senate Appropriation \$2,000,000

Community/Notifications of the project were also outlined.

Councilmember Frazier – Ms. Frazier began by thanking Heather Colin for the information. She stated there are times where disagreements occur. It is acceptable to disagree and have passionate voices, however, the passionate voices have been providing misinformation that a lot of times will create a level of distrust and disdain for government and those who are stewarding the projects. She advised that council is sensitive to the need to meet the esthetics of the town and provide to the needs of the inclusive community to include all citizens. This includes someone who may be in a wheelchair or have mobility issues accessibility to the features and green spaces that we do have. Ms. Frazier spoke about the individuals wanting the money to be spent on other things. She expressed the need to understand grants are earmarked for a specific purpose. The funding cannot be utilized for any other purpose other than what the grant has been written for. She also expressed the importance of staying off social media and away from sensationalism. She encouraged citizens to reach out, ask questions as the town has an opendoor policy.

Mayor Larry Toomer – Mayor Toomer spoke regarding the speed of the project stirring discontent within the community within just a few days. He advised he understands those who are opposed to anything improving in their backyard. He stated people want affordable housing, more public parks, and playgrounds but not too close to "my house". This is what council and staff go through to get projects done that benefit the community. He advised in the 12 years he has sat on the dais he has heard numerous requests for trails, bike paths and walking paths to enable people to stay off the dangerous roadways. He stated the project has been in the pipeline for many years and feels the town needs to stick to the plan and move forward with the project for the betterment of the entire community.
