Town Council and staff members discussed options for the proposed amendments to the noise ordinance.

The proposed amendments include:

- Resolve conflicting language for special events and applicability of the noise ordinance;
- Decrease in decibels during specific times; and
- Restriction of 6 hours of continuous play of outdoor entertainment or music.

A motion made by Councilmember Frazier; Seconded by Councilmember Hamilton to approve the second and final reading of an Ordinance Amending Chapter 2 and Chapter 21 of the Town Code as related to the Declaration of a Local Civil Emergency and Other Matter Related thereto.

Town Council unanimously approved the second and final reading of this ordinance.

2. Resolution to Approve Multi Party Agreement Between Buckwalter Association Inc., Beaufort County, and Town of Bluffton to Construct the Connection Road Between Buckwalter Place and Washington Square – Heather Colin, Assistant Town Manager

A motion made by Councilmember Frazier; Seconded by Councilmember Hamilton to authorize the Town Manager to execute all necessary documents, including the acceptance of the right-of-way deed, submitting all required plats and to make any amendments that do not change the project scope or overall cost as outlined in the attachments and exhibits.

Town Council unanimously approved.

3. Proposed Amendments to the Town of Bluffton Code of Ordinances to include Regulations Addressing Abandoned and Derelict Boats in the Town's Waterways – First Reading – Heather Colin, Assistant Town Manager

A motion made by Councilmember Burden; Seconded by Councilmember Hamilton to authorize the first reading of an Ordinance Amending the Town of Bluffton Code of Ordinances, Chapter 13, to include Article III to Establish Procedures, Requirements, and Penalties for Derelict, Abandoned, and Sunken Vessels and Other Matters Related.

Town Council unanimously approved the first reading of this ordinance.

4. Consideration of an Ordinance Approving a Real Property Exchange Agreement between the Town of Bluffton and the Beaufort County School District for Certain Real Property Owned by the Town of Bluffton within Buckwalter Planned Unit Development Identified as R610-022-000-1094-0000; and Authorizing Execution and Recording of Certain Documents Therewith – First Reading – Kevin Icard, Director of Growth Management

A motion made by Councilmember Hamilton; Seconded by Councilmember Frazier to approve the first reading an ordinance authorizing the Town Manager, in consultation with legal counsel, to execute all necessary documents, including the extinguishment of the easement agreements, land swap agreement, and the purchase and sales agreement and to make any amendments that do not change the project scope as outlined in the attachments and exhibits.

Town Council unanimously approved the first reading of this ordinance.

 Consideration of an Ordinance Amending the Town of Bluffton Fiscal Year 2026 Budget to Provide for the Expenditures of Certain Funds; and to Allocate Sources of Revenue for the Said Funds to Carryover Unspent Expenditures and Encumbrances from the FY2025 Budget to the FY2026 Budget. First Reading - Natalie Majorkiewicz, Director of Finance

A motion made by Councilmember Burden; Seconded by Councilmember Hamilton to approve an ordinance amendment for the Town of Bluffton Fiscal Year 2026 Budget to provide for the expenditures of certain funds; and to allocate sources of revenue for the said funds to carryover unspent expenditures and encumbrances from the FY2025 Budget to the FY2026 Budget.

Town Council unanimously approved the first reading of this ordinance.

6. Consideration of Accommodations Tax Advisory Committee Funding Recommendations for Quarter Ending June 30, 2025. Natalie Majorkiewicz, Director of Finance

A motion made by Councilmember Frazier; Seconded by Councilmember Hamilton to approve a \$20,000 grant to the Michael C. Riley School Alumni Association in support of Phase III of MC Riley Commemorative Garden and Wall refurbishing project.

Town Council unanimously approved the grant.

A motion made by Councilmember Burden; Seconded by Councilmember Hamilton to approve a \$10,000 grant to the Coastal Conservation Association in support of the 2025 Celebrating Conservation Weekend in Bluffton project as presented in the Staff Report breakdown for advertising and promotion expenses.

Town Council unanimously approved the grant.

A motion made by Councilmember Hamilton; Seconded by Councilmember Burden to approve a \$40,000 grant to the Society of Bluffton Artists in support of the Getting the Work Out project for fiscal year 2026.

Town Council unanimously approved the grant.

A motion made by Councilmember Burden; Seconded by Councilmember Hamilton to approve an \$80,000 grant to the Historic Bluffton Arts and Seafood Festival Inc. in support of the 2025 Historic Bluffton Arts and Seafood Festival.

Councilmember Frazier recused herself from this item. Councilmembers Burden, Hamilton and Wood approved the grant.

A motion made by Councilmember Frazier; Seconded by Councilmember Burden to approve a \$109,000 grant Campbell Chapel Community Development Ministry is support of Phase 3 of the restoration and rehabilitation of the Historic Campbell Chapel project.

Councilmember Hamilton recused himself from this item. Councilmembers Burden, Frazier and Wood approved the grant.

A motion made by Councilmember Burden; Seconded by Councilmember Frazier to approve a \$10,000 grant to the Campbell Chapel AME Church in support of the 162nd South Carolina Conference of the AME Church.

Councilmember Hamilton recused himself from this item. Councilmembers Burden, Frazier and Wood approved the grant.

A motion made by Councilmember Hamilton; Seconded by Councilmember Frazier to approve a \$6,5000 grant to the Historic Bluffton Foundation in support of the 2025 Fall Tour of Homes.

Town Council unanimously approved the grant.
