Background:

- PST CAROLES
- January 2021: Town of Bluffton purchased the .896-acre Sarah Riley Hooks property and cottage.
- November 2022: Town Council added the Sarah Riley Hooks project to the Capital Improvement Program with the FY 2023- FY 2024 Strategic Plan.
- January 2023: Growth Management Staff presented initial Cottage -Viability of Preservation Assessment.
- April 2023: Historic Preservation Consultant (Meadors Inc.) presented:
 - Provided an update to the current state of the structure
 - Recommendations for building configuration and floor plan
 - Redevelopment options (new structure with salvage of historical materials or demolish and replicate)
- April 2023: CIP Staff Presented:
 - Results of Public Opinion Surveys
 - Conceptual Master Plan

Background:

SUMMARY OF COUNCIL FEEDBACK PROVIDED AT WORKSHOPS:

- Incorporate family history into any future plans.
- Provide public access and restrooms, but not event space use.
- No kayak launch or access to the cove via stairs.
- Respect surrounding neighbors for any use.
- Prefer to keep building spaces open and flexible to accommodate different uses including art and music classes.
- Add cameras and site lighting for security.
- Add more places to sit including picnic tables.
- Minimize parking and maximize green space.




Project Scope: Cottage Rendering:

Procurement:

- EST CAROLINA
- Town posted a Request for Proposals on 3/1/2025 and received 3 compliant proposals on 3/26/2025.
- Bids were evaluated for completeness and company qualifications, experience, value, and project proposal.
- Nix Construction was determined to be the most qualified responsible bidder.

Request:

- OF BITTER OF THE PROPERTY OF T
- Staff requests Town Council authorize the Town Manager to execute a contract with Nix Construction, Inc. for \$857,680.00 to complete construction of the Sarah Riley Hooks Cottage improvements.
- Additionally, Staff requests a 10% contingency allowance of \$85,768.00 to cover any unforeseen changes that may arise during construction.
- The total fiscal impact is \$943,448.00 and is within the approved budget for Fiscal Year 2025.

Next Steps:

- Following Council approval, Staff will submit the Contract for signatures and initiate the preconstruction meeting.
- A Notice to Proceed (NTP) will be issued at the preconstruction meeting and work is planned to commence in June 2025.
- Construction duration is estimated to be approximately 300 calendar days.
- Bid site development construction in May 2025.
