Good afternoon, Jeff;

Thank you for the early coordination concerning the proposed Tommy's Express project on Simmonsville Road in Beaufort County.

After reviewing the attached concept plan for access locations, our office has no objection to the proposed project. We do have the following comments on the proposed driveway.

- 1) The proposed driveway will have to be restricted to right-in/right-out movements due to not meeting spacing requirements from Bluffton Parkway and the opposite driveway on Simmonsville Rd. Attached is a typical design for a RIRO driveway with offset sidewalk.
- 2) The driveway must tie in to Simmonsville Road at a 90-degree angle.
- 3) A traffic study is not required for the proposed development on this site.

During site design, please check SCDOT Plans Online for as built road plans to indentify any drainage structures that may have been placed in the RW during road construction and for any controls of accesshttps://falcon.scdot.org/falconwebv4/default.aspx
