Town Council approve the proposed amendments to Code of Ordinances, Town of Bluffton, Chapter 6, Businesses and Business Regulations, Article III, Soliciting, Section 6-78, Approvals, fees and taxes, Section 6-83 Fire Safety, Section 6-84 Violations and Penalties;

Background



In 2017, the Town of Bluffton adopted mobile vending requirements in Chapter 6 – Businesses and Business Regulations, Article III – Soliciting and Mobile Vending. The Ordinance was enacted to regulate allowed locations, hours of operation, permitting processes and other miscellaneous issues for mobile vendors (food trucks) in Bluffton.

In 2021, the Town amended its Business License Ordinance as required by the State of South Carolina per Act 176 that became effective January 1, 2022. One item of the Act was requiring all business licenses have an annual license beginning on May 1st of each year.
