## Town Operations / Community Meetings

- Town Operations have begun to shift back to more normal operations. However, we are watching the new increase in cases with the Omicron variant and how it may affect operations. We are also updated protocols on exposure and return to work based on new CDC guidelines. We are also waiting on the Supreme Court to review the President's Vaccine Mandate and what we may need to do for compliance. We have also reached out to Beaufort Memorial for any recommendations and/or adjustments they may make.
- We completed interviews and have hired a new Emergency Manager that will start January 13<sup>th</sup>. His name is Stephen Combs and comes from Anderson County Sheriff's Office. An email was sent to Council with information and background.
- I made a presentation to the Bluffton Regional Business Council about growth and capital projects that we are working towards.
- Town Manager from Beaufort County and Hardeeville met with Beaufort County to discuss updating the Transportation and Park Impact Fees. This update included requests from the town's and led to a larger discussion of road improvement funding. An update on this meeting was shared with Council.

## Town Council/Town Attorney Related Meetings

- Weekly Mayor / Mayor Pro Tempore / Town Manager meetings.
- Council voted to send Palmetto Bluff's development amendment request to Negotiating Committee at the November meeting. The Negotiating Committee is scheduled to meet Thursday, January 6<sup>th</sup> at 10:00 am in Council Chambers. An update from that meeting will be shared with Council.
- The Mayor and I met with Scott Wierman on December 6<sup>th</sup>. He is the President and CEO of the Community Foundation of the Lowcountry. Allen Ward, a Foundation Board member, was also at the meeting. We discussed the purpose and success of the Foundation and potential ways that we could work together. We also discussed their partnership with Hilton Head Island in administering some of their ARPA grant programs.
- Mayor Pro Tempore Hamilton and staff meet with the County virtually for our bi-monthly meeting. An update on this meeting and topics of discussion were sent to Council.
