

AMENDMENT

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc. with offices at One Tyler Drive, Yarmouth, Maine 04096 ("Tyler") and the Town of Bluffton, with offices at 20 Bridge St., Bluffton, SC 29910 ("Client").

WHEREAS, Tyler and the Client are parties to an agreement dated May 20, 2022 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the terms of the Agreement as provided herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the Client agree as follows:

- 1. The removal date for the following Tyler Software as a Service (SaaS) modules removed from the Agreement pursuant to the amendment between the parties dated July 31, 2025, is hereby amended to July 15, 2025:
 - a. ACFR Statement Builder
 - b. Time and Attendance Advanced Scheduling Mobile
 - c. Time and Attendance Advanced Scheduling Up to 75 Employees
 - d. Recruiting
- The SaaS term and invoicing for the period commencing July 15, 2025, shall be prorated to end June 30, 2026. Thereafter, annual fees shall be invoiced for the period July 1 through June 30 each year.
- 3. Tyler will issue to Client a revised annual fee invoice reflecting the prorated current term, as well as the removal of the modules referenced in Section 1 of this Amendment.
- 4. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
- 5. Except as expressly indicated in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
