Project Description:

The 162nd South Carolina Annual Conference of the AME Church will bring together representatives from 96 AME churches from the state's southern border up to Charleston, S.C. And for the first time since 2016, it is being hosted by Campbell Chapel AME Church in Bluffton, SC.

Though it carries the name of the South Carolina Annual Conference, its members represent one of six Conferences (Regionals) across the state of South Carolina. Our goal is to provide such "Radical Hospitality" to attract the Annual Conference back to Bluffton more frequently.

Over the course of four days, Wednesday, September 17th 2025, through Saturday, September 20th, 2025, over 1,000 representatives, including 250 designated delegates, will rotate through different segments of the Conference based on their areas of responsibilities and focus on:

- Business, Training and Worship
- Missionary Outreach
- · Women's, Men's and Young People's Ministries
- · Clergy and Lay Appointments and Service
- Church School and Christian Education

We have reserved 150 hotel rooms across four hotels:

- Holiday Inn Express, 35 Bluffton Road, Bluffton (Host Hotel) 50 Room Block
- Spark by Hilton, 23 Towne Drive, Bluffton 30 Room Block
- Best Western Plus, 259 Okatie Village Drive, Bluffton 40
 Room Block


