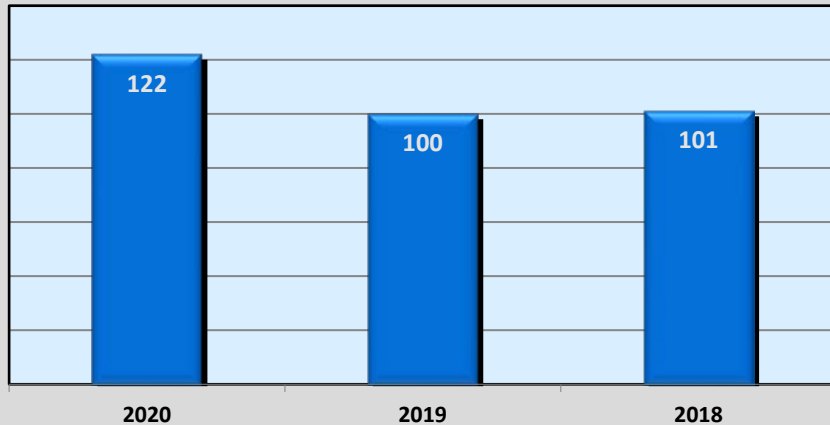

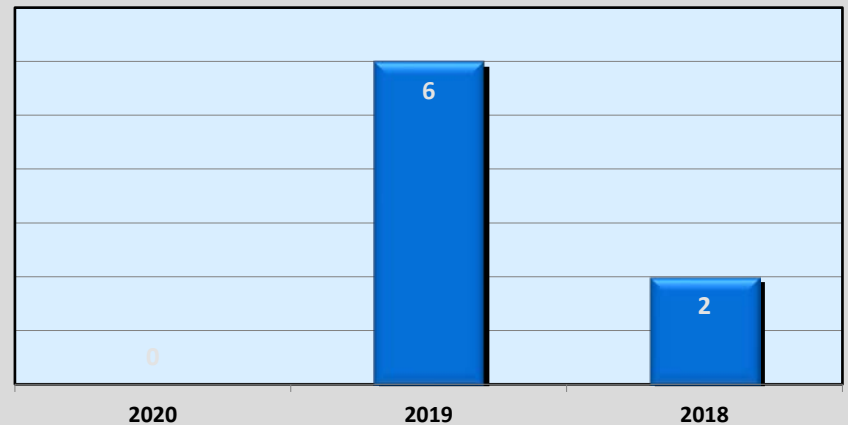
December Traffic Citation Comparison



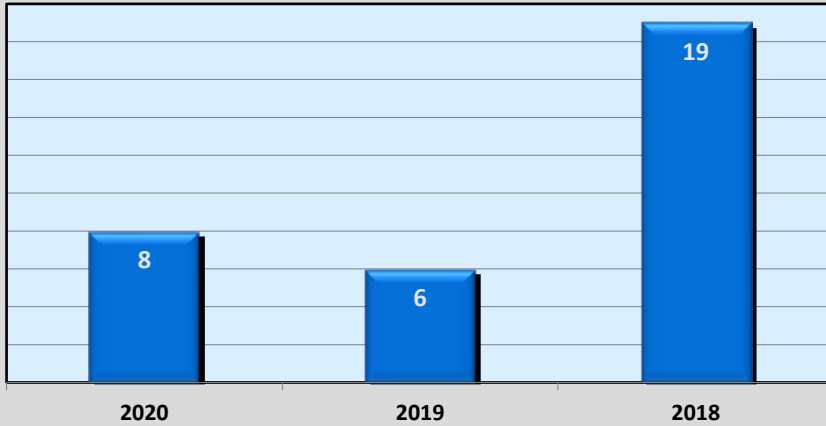
December Collision Comparison



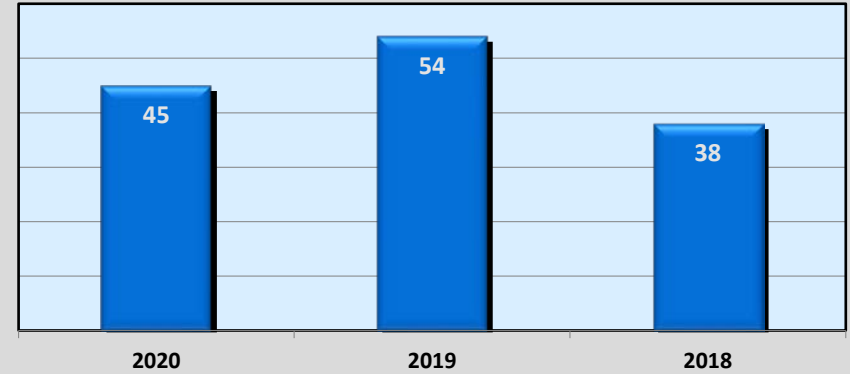

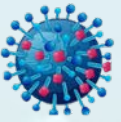
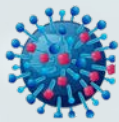


COVID-19 Pandemic South Carolina



CONFIRMED CASES - SC CONFIRMED CASES - BEAUFORT CTY DEATHS - SC



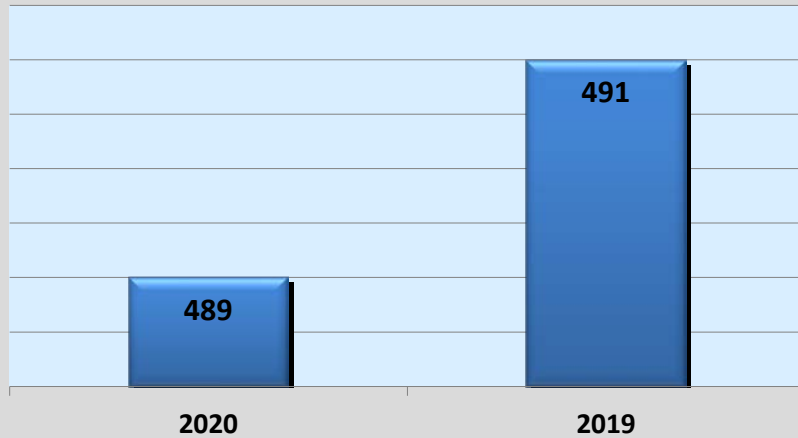

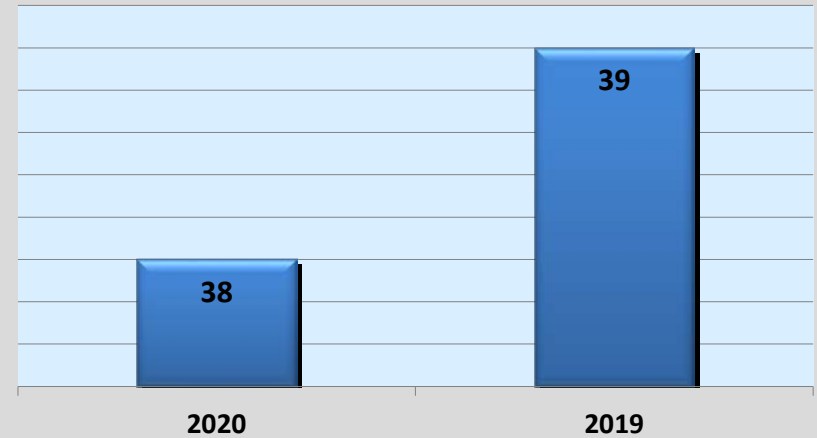

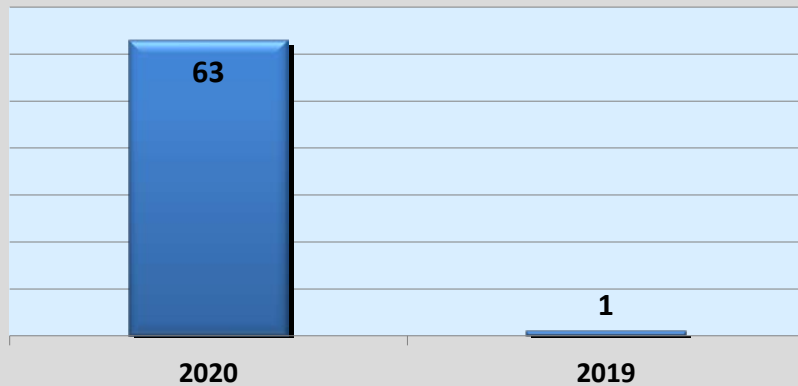
Domestic Comparison



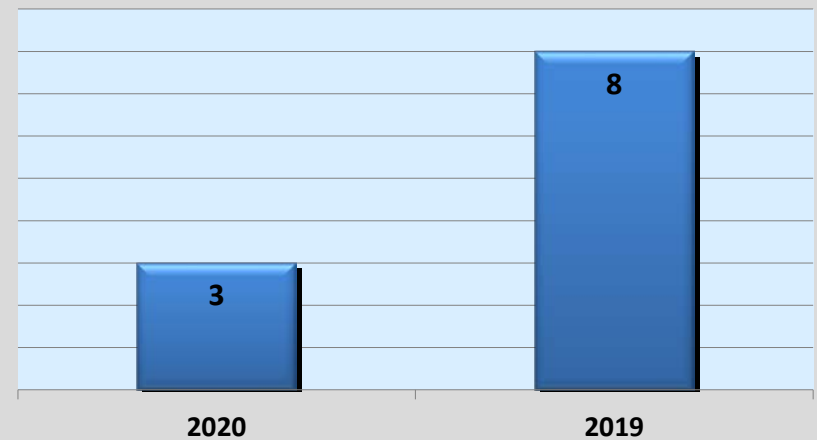
Assault & Battery Comparison

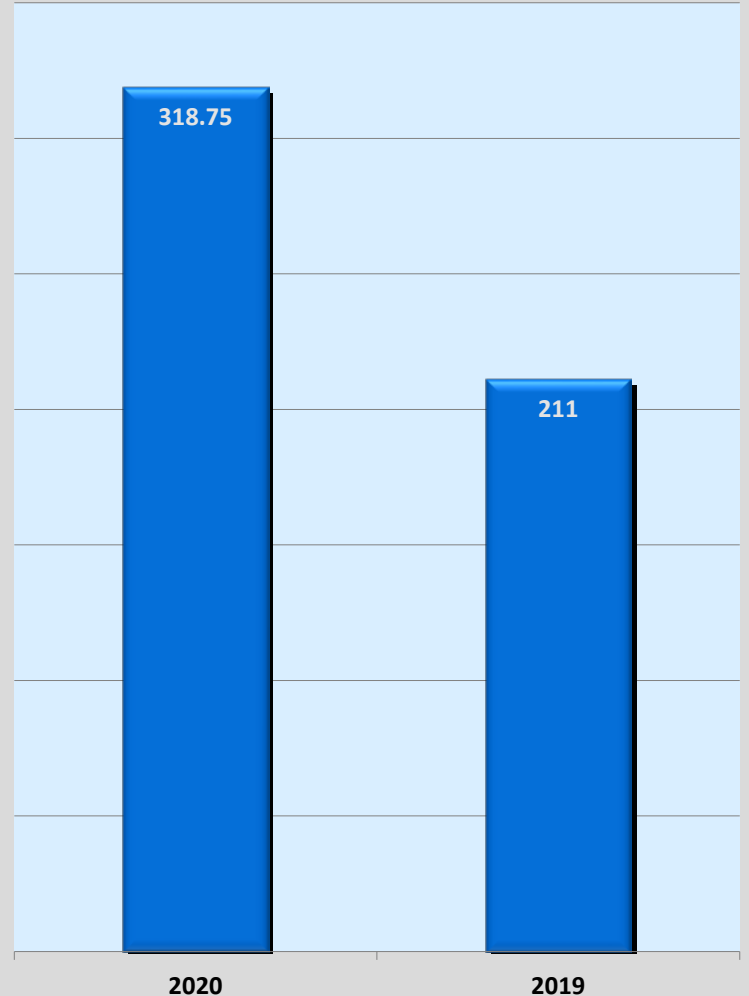

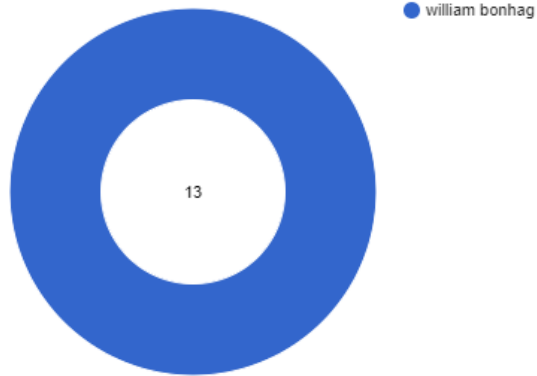

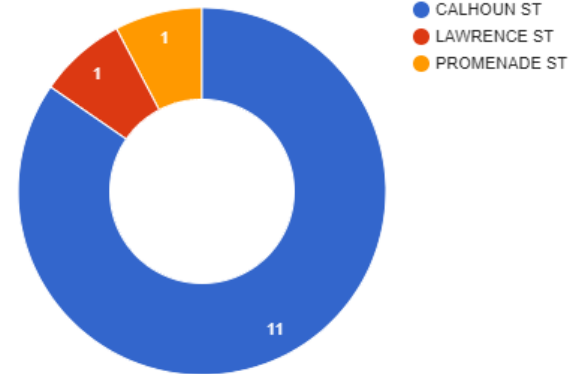
Tickets By Officer Dec. 2020

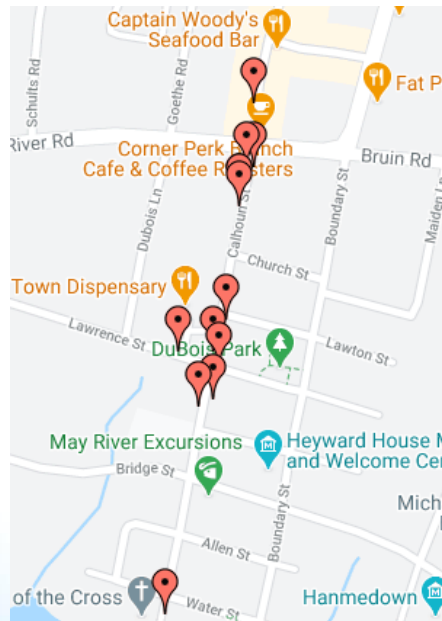

Tickets By Location Dec. 2020

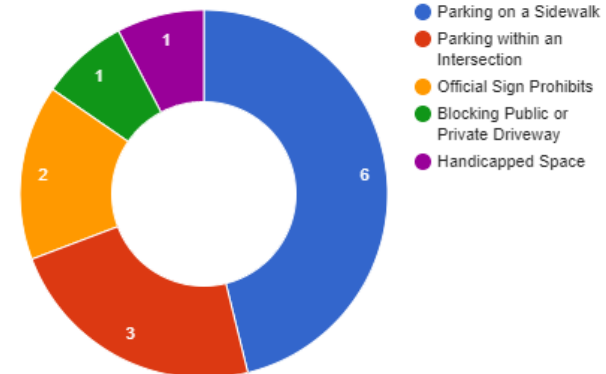
