Date: November 20, 2025

Three Planning Commission members, based on the required rotation, find their terms ending at the end of December – Micheal Connell, Jennifer Leighton, and Jami Carbray. Micheal Connell is requesting to be reappointed; Jennifer Leighton and Jami Carbray are not seeking reappointment.

As we do every year at this time, a Press Release was pushed out, indicating the vacancies and seeking interested parties. Four letters of interest have been received and are a part of this packet – Jolene Stensland, Rod Taylor, Carol Maidment Jones, and Natasha Rockwell.

I would recommend to the City Council that Micheal Connell be reappointed to the Planning Commission. Should the Council take that action it would leave two vacancies to be filled.

A second recommendation would be the appointment of Rod Taylor based on his long tenure on the Morrow County Planning Commission with a known understanding of basic planning process which is comparable between jurisdictions. And based on the Municipal Code one member of the Planning Commission can live outside of the city limits within the influence area (which I would interpret as the zip code area). There is historical precedent of members serving on the Planning Commission that did not reside within the city limits – Jacob Cain and Glaya Baker. Both were long serving and both served as Chair.

Should the Council concur with my recommendations above, for the final vacancy the Council has three individuals to consider – Jolene Stensland, Carol Jones, and Natasha Rockwell. Carol, in her letter of interest, indicates that she did serve on the Planning Commission many years ago. Easily accessible records of appointment do not go back far enough to confirm this. I only know one of these three individuals and cannot in fairness provide any more insight than each of you may have.

BOARDMAN PLANNING COMMISSION VACANCY

The City of Boardman is seeking interested parties who live within the Boardman City Limits or in

the 97818 Zip Code to serve on the Planning Commission. Three positions will be appointed at the

December 2nd, 2025 city council meeting with the first Planning Commission meeting following

appointment scheduled for January 15th, 2026. The term for these positions would end on December

31, 2028.

The Planning Commission is comprised of seven members appointed by the City Council and is a

permanent advisory body to the Council on matters related to planning and development. The

Commission holds monthly public meetings to consider land use and zoning matters presented by staff,

such as plan amendments, zone changes, conditional use permits, variances, and tentative subdivision

projects. Meetings are generally on the third Thursday of each month at 6 p.m. at Boardman City Hall
