

## **RESOLUTION 2025-02**

### **A RESOLUTION OF THE CITY OF BONIFAY, FLORIDA ESTABLISHING A FEE SCHEDULE FOR CONNECTION TO WATER AND SEWER UTILITIES; PROVIDING FOR SCRIVENER'S ERRORS; PROVIDING FOR LIBERAL INTERPRETATION; PROVIDING FOR REPEAL OF CONFLICTING RESOLUTIONS AND FEE POLICIES; AND PROVIDING FOR AN EFFECTIVE DATE**

#### **BE IT RESOLVED BY THE CITY COUNCIL OF BONIFAY, FLORIDA AS FOLLOWS:**

**SECTION 1: ESTABLISHMENT OF A WATER AND SEWER CONNECTION FEE SCHEDULE.** There is hereby established a Water and Sewer Utility Connection Fee Schedule as attached hereto, which is incorporated herein by reference. The connection fees set forth in the Water and Sewer Utility Connection Fee Schedule shall be charged to any customer connecting to the City's potable water and/or sewer utilities on and after the Effective Date set forth herein.

**SECTION 2: SCRIVENER'S ERRORS.** The correction of typographical errors which do not affect the intent of this Resolution may be authorized by the Mayor or the Mayor's designee, without public hearing, by filing a corrected or re-codified copy with the City Clerk.

**SECTION 3: RESOLUTION TO BE LIBERALLY CONSTRUED.** This Resolution shall be liberally construed in order to effectively carry out the purposes hereof which are deemed not to adversely affect public health, safety, or welfare.

**SECTION 4: REPEAL OF CONFLICTING RESOLUTIONS AND POLICIES.** Resolutions, or parts of resolutions or portions thereof of the City of Bonifay, and policies of the City relating to the subjects hereof, in conflict with the provisions of this Resolution are hereby repealed to the extent of such conflict.

**SECTION 5 – EFFECTIVE DATE.** This Resolution shall take effect immediately upon adoption.
