NON- AGENDA AUDIENCE

A. Matthew Fuqua - Farmer Property

Attorney Matthew Fuqua informed the Council Members that he was representing the Farmers and was here to talk about an easement. Around 1985 a garage was constructed and it encroaches 7 feet onto an unused portion of State Street, which is 75 feet wide. The buyer is unable to obtain financing because of the encroachment.

City Attorney Holloway suggested a license agreement, which could be removed in the future if needed and is the safest route for the City.

Attorney Fuqua believed that a license agreement will not satisfy the title company.

Council Member Crews asked City Attorney Holloway to word the motion.

City Attorney Holloway stated the motion would be to approve a license agreement that gives permission for the 7-8 feet to exist until such time in the future the Council requires its use, and the portion of the building encroaching onto State Street would be removed.
