V. VISITORS – PUBLIC ADDRESSING THE COUNCIL

NON- AGENDA AUDIENCE

Effective October 1, 2013, Florida Statute 286.0114 mandates that “members of the public shall be given a reasonable opportunity to be heard on a proposition before a Board or Commission.” Each individual shall have three (3) minutes to speak on the proposition before the Board.

Jason Powell appeared before the Council inquiring about City Clerk Callahan calling him earlier in the day and advising him the the Holmes County Chamber of Commerce was asking that the political signs he had place along Veteran's Boulevard be remove during the weekend due to the Down Home Street Festival being held and Veteran's Boulevard being where vendors set up. Attorney Michelle Blankenship-Jordan advised that the Down Home Street Festival had a Facilities Use Agreement with the City for exclusive use of that area during the Festival. Mr. Powell stated that he would take care of it.

Mr. Powell also asked the Council if they "want to spend taxpayer money to hire an attorney to pursue a claim against Holley Develepment" in reference to the construction of the Fire Department Expansion. Both Mayor Travis Cook and Vice-Mayor told Mr. Powell that yes, it needed to be pursued due to issues found in two different inspections, and the City of Bonifay didn't get what they paid for.

A. Hire Attorney for Bonifay Fire Department Bond Claim

City Attorney Michelle Blankenship-Jordan had been directed by the Council to find an attorney who specializes in Construction Law, and she reported that she had checked around and found an attorney out of Pensacola, FL , Joseph A. Passeretti with Beggs & Lane at a rate of \$325. per hour, and recommended that the Council sign a Letter of Engagement which she presented to pursue a claim on the Fire Department Expansion Project.
