Re: Recommendation of Award

TWDB DWSRF No. 62913 (CID 01) – Contract A / Water Distribution System Improvements

Dear Mayor Sims:

Bids for the referenced project were opened on April 2nd, 2025. Two (2) bids were received, and the bid tabulation was published the same day. The bid tabulation is attached for reference. The apparent low bidder is Raydon, Inc., of Breckenridge, Texas.

The responsiveness of the bidder has been evaluated for conformity with all material conditions of the Advertisement to Bid and the Information for Bidders.

The TWDB project includes approximately \$2.1 million in loan/grant funding available for water line replacement construction.

Based upon the evaluation findings, it is recommended that the construction contract for the City of Breckenridge – TWDB DWSRF (No. 62913) (CID 01) / Contract A – Water Distribution System Improvements Project be awarded to Raydon, Inc., as the lowest, qualified bidder, in the total amount of \$1,509,347.00 (base bid) and \$865,226.20 (Add Alt 2) for a total contract amount of \$2,374,573.20.

A subsequent deductive change order will be developed to reduce the contract down to the intended budget for the planned improvements.
