Parcel Two - 0.02 Acre Tract

All that certain 0.02 acre tract or parcel of land in the City of Breckenridge, situated in the southwest quarter of Section 10 of the Lunatic Asylum Lands, original grantee W. C. Pulley, Abstract Number 1348, patentee J. M. Garner, patent filed 30 July 1886, and recorded in volume A page 137 of the Patent Records of the County of Stephens, State of Texas, said tract being part of Stocker Avenue of Hi-Mount Addition, an unrecorded addition to the City of Breckenridge, and evidenced by affidavit to the Public filed 15 June 1948, and recorded in volume 222 page 458 of said deed records and by plat of the City of Breckenridge located in the Plat Cabinet in Slide 24A of the Plat Records of said Stephens County, and being more particularly described as follows;

COMMENCING at a pipe fence corner post, said post being the southwest corner of the occupied and bounded tract on the ground of a called 24.5 acre tract as described in deed to Wm. Pardue, Jr., filed 01 July 1942, and recorded in volume 190 page 24 of the Deed Records of said Stephens County, same being the southeast corner of Tract Two, a called 9.24 acre tract as described in deed to Darrell E. Shortes and Susan D. Shortes, Trustee, filed 12 September 2014, and recorded in volume 2075 page 487 of the Official Public Records of said Stephens County, said post being the southeast corner of said A-1348, same being the southwest corner of the southeast quarter of Section 10 of said Lunatic Asylum Lands, original grantee and patentee W. Brown, Abstract Number 955, patent filed 09 December 1881, and recorded in volume D page 581 of said patent records, and said post being the northwest corner of the northeast quarter of Section 13 of the Lunatic Asylum Lands, original grantee J. R. Blessing, patentee J. A. Stewart, Abstract Number 1074, patent filed 02 July 1886, and recorded in volume A page 130 of said patent records, same being the northeast corner of the southwest quarter of Section 13 of the Lunatic Asylum Lands, original grantee J. R. Blessing, patentee Sarah Brown, Abstract Number 33, patent filed 02 July 1886, and recorded in volume A page 130 of said patent records, from said post, a point being the southwest corner of said A-1348 bears South 89 degrees 41 minutes 41 seconds West, a distance of 2624.22 feet, said post also having NAD83 SPC NCTZ (4202) grid coordinates of N:6954050.21, E:1847377.57;

THENCE: North 00 degrees 36 minutes 11 seconds East, with the west line of said Pardue 24.5 acre tract, and with a barbed wire fence and passing at 105.5 feet a set 1/2 inch rebar by a pipe fence corner post, and continuing on said course, another 347.95 feet to a point being an extension of the north line of said Chesley Street;

THENCE: North 82 degrees 32 minutes 09 seconds West, with the north line of said Chesley Street, a distance of 367.18 feet to a set 1½ inch rebar at the intersection of the north line of said Chesley Street and the west line of said Stocker Avenue being the southeast corner of Block 33 of said Addition;

THENCE: North 07 degrees 31 minutes 05 seconds East, with the west line of said Stocker Avenue and with the east line of said Block 33, a distance of 158.11 feet to a set 1½ inch rebar on the south line of the City Limits of Breckenridge, as established by Ordinance Annexing Territory passed & approved 21 July 1920, and in Book 1 page 3, certified copy dated 24 March 1928 by E. D. Baccus, City Secretary, Book 1 page 246 in the records of the City of Breckenridge for the **POINT OF BEGINNING** and the southwest corner of the tract being described herein;

THENCE: North 07 degrees 31 minutes 05 seconds East, with the west line of said Stocker Avenue and with the east line of said Block 33, a distance of 128.73 feet to a set 1½ inch rebar on the east line of said city limits for the north corner of this tract;

THENCE: South 00 degrees 36 minutes 11 seconds West, with the east line of said city limits, a distance of 127.55 feet to a set 1½ inch rebar for a southeast corner of said city limits and the southeast corner of this tract;

THENCE: South 89 degrees 41 minutes 41 seconds West, with the south line of said city limits, a distance of 15.50 feet to the **POINT OF BEGINNING** and containing 0.02 of an acre of land.
