**PROCLAMATION:** Commending Brian Scabbo Mayor Hruby presented a **COMMEND** proclamation recognizing Detective Brian Scabbo for his work to obtain a murder conviction **BRIAN** for a drug dealer responsible for the overdose death of a Brecksville resident. **SCABBO** 

"Detective Brian Scabbo has displayed a personal commitment and perseverance to the betterment of the City of Brecksville and provided a safer community through his dedication as a Detective in the Brecksville Police Department; and

WHEREAS: Brian was hired by the City of Brecksville on March 3, 2008 and was assigned to the Detective Bureau in April 2017. He has achieved his Master Criminal Investigator certification through the Ohio Peace Officer Training Academy and currently serves as the Assistant Commander of the Southwestern Enforcement Bureau- East Region SWAT Team; and

**WHEREAS:** Detective Scabbo was assigned to a case on September 16<sup>th</sup>, 2021 where the victim subsequently passed due to drug overdose; and

**WHEREAS:** Through Brian's investigative skills and evidence collection abilities he was able to identify the drug dealer that sold the victim the drugs that caused the fatal overdose. These types of investigations are hard to prove and take a long time to complete, however, Detective Scabbo was able to provide sufficient evidence to the Cuyahoga County Grand Jury to obtain an indictment.; and

**WHEREAS:** Almost two years after this tragic incident, through Detective Scabbo's continued persistence of the case, the drug dealer pled guilty to the charge of Involuntary Manslaughter, and as punishment, received a seven and a half year prison sentence; and

**WHEREAS:** Brian's personal commitment to hold the individual responsible for this tragic death is commendable. He not only made the community safer by removing a dangerous drug dealer from society, but he obtained justice for the victim and the victim's family.

**NOW THEREFORE:** I, Jerry N. Hruby, Mayor of the City of Brecksville, hereby salute Detective Brian Scabbo on his dedication, bravery, and unwavering service to the public safety of our fine community.

"For 40 years, Brian Stucky has dedicated his life to coaching, teaching and inspiring **STUCKY** young athletes to learn teamwork, and along the way he taught not only athletic skills

but invaluable life skills; and WHEREAS: Brian's journey as a coach began at Hocking Hills Junior High School in 1983 as assistant track coach. **WHEREAS:** You've heard of travel teams, but he has been a travel coach! The stops include Olmsted Falls HS, Rocky River HS, Brecksville-Broadview Heights HS, up the scholastic ladder to John Carroll, and then back home to the Bees Soccer Academy and the Brecksville Travel Baseball Association. Track, football, wrestling, girls softball and soccer. What a resume! and

WHEREAS: In 2004 while coaching the Blue Streaks wrestling team, home called and Brian added his son's U6 soccer team. And that led to teaming up with the legendary soccer coach, Tony Niccoli. Together they founded the Brecksville Soccer Academy in 2007 which is still thriving after 16 years; and

**WHEREAS:** Brian has been a dedicated volunteer coach for the Soccer Academy and initiated the Run For Your Life Program, between the two, spending over 3,000 rewarding and fulfilling hours aimed at helping area kids. Was he hard on them at times? Yes, because he wanted to push them to be the best they could be; and

WHEREAS: He has received volumes of letters from players thanking him for life lessons learned as a result of his guidance making his coaching career highly rewarding and certainly worthwhile. But the time has come. His last day as a coach was October 15, 2023. He was honored to be called, "Coach." and
