# L. Ordinance Revising the Start Time of City Council Meetings to 6:30 P.M

(It is being recommended to amend Section Chapter 2.44.010 of the Brisbane Municipal Code changing the City Council's regular meeting time from 7:30 p.m. to six thirty (6:30 P.M.) by (1) adopting the attached Ordinance on an urgency basis and (2) introducing on first reading a parallel, but non-urgency Ordinance.)

City Manager Dennis reported that staff was directed to draft an ordinance to change the City Council's regular meeting time from 7:30 p.m. to six thirty (6:30 P.M.) to increase public engagement. The council has to decide whether to adopt an urgency ordinance that will take effect immediately and allow Council meetings to begin at 6:30 p.m. beginning February 20<sup>th</sup> or a non-urgency ordinance that will amend the Code but will require a second reading on February 20 and would not go into effect for 30 days, meaning that meetings could not begin at 6:30 until Council's first meeting in April.

After Council questions, no public comment, and Council discussion, Councilmembers Davis and Councilmember O'Connell noted their preference for the non-urgency ordinance and their desire to provide more time for members of the community to be informed about the meeting time change. Councilmember O'Connell made a motion, seconded by Councilmember Davis, to introduce the non-urgency Ordinance to amend Section Chapter 2.44.010 of the Brisbane Municipal Code changing the City Council's regular meeting time from 7:30 p.m. to six thirty (6:30 P.M.). # M. Receive an Update Regarding the Creation of Potential Council Election Districts

(It is recommended that the City Council receive an update regarding the creation of potential Council election districts and provide direction to staff on the timeline and outreach.)

City Manager Dennis introduced Justin Levitt and Douglas Johnson of NDC Research to provide an update on the creation of potential City Council Election Districts as well as the proposed timeline and outreach plan. Dr. Levitt summarized that the following timeline is being proposed:

- 1. Two hearings to educate community and gather community input within 30 days
- 2. Two hearings to review and revise draft maps within 45 days
- 3. Additional community workshops as needed
- 4. Council selects final map
- 5. First by-district elections held in 2026

After Council questions, public comment was given by the following members of the community: <a href="Julie Sims">Julie Sims</a> commented that election districts is problematic for a town our size.

Michele Salmon commented that she is against district elections because it will do harm and is divisive.

Chris Florkowski did not recall Council taking action and had serious doubts about the researcher's findings.

After Council discussion, staff were directed to schedule a closed session to discuss the item as an anticipated litigation. Staff were also directed to coordinate the timeline as appropriate to the Council's meeting schedule.

## N. Discuss Fiscal Year 2026 Congressional Appropriation Requests

City Manager Dennis reported that in March of every year, the Congressman Kevin Mullin's office opens a portal for use by municipalities and other eligible partners to submit their project for inclusion in the congressional appropriations process. Requests submitted are publicly viewable once requested. The types of projects that may be supported include the following:

- Community Centers
- Sewer and drainage projects
- Street and highway safety improvements
- Trail support

After council questions and no public comment, Council directed staff to provide a proposal at a future meeting for the renovation of the Community Center and old library space. Council was also interested in requests for traffic calming project in Bayshore near the mobile park, sewer and potable water issues in Sierra Point, stability of land in San Bruno Avenue.
