The Commission asked about the methodology the Association of Bay Area Governments (ABAG) used to determine the distribution of the Bay Area's Regional Housing Needs Allocation (RHNA) and its feasibility as applied to Brisbane, the timing to certify the region's final RHNA number and if Brisbane's number might change, how the City might certify a site to qualify for low or moderate housing, the difference between new requirements that must affirmatively further fair housing and address environmental justice, and the role of 21 Elements in the update process.

They highlighted upcoming community meetings and workshops in April for both the 2023-2030 Housing Element update and the development of objective design and development standards for new residential development.

Commissioner Sayasane gave a brief report on the Baylands subcommittee meeting held on March 18, 2021, indicating that the developers provided the subcommittee a detailed 3D model and will submit a Specific Plan in April.
