G. Consider Adoption of a Resolution for Water and Sewer Rate Increase

Council will consider a Resolution increasing the charges for water and sewer services and setting the discount rate for the city's low-income rate assistance plan at 25% for all services.)

Finance Director Yuen noted that on April 3, 2023, a public hearing was held to discuss the proposed increases to the water and sewer rates. The school district within the City was on spring break and other religious holidays were being observed the week of the initial public hearing. The Council wanted to provide residents and property owners an additional opportunity to express their views and ask questions, and therefore continued the public hearing to April 20,

2023. Catherine Tseng of Lechowicz & Tseng Municipal Consultants provided a brief overview of the water and sewer services and the low income rate assistance plan.

After some council questions, Mayor Davis reopened the public hearing. No public comments were received.

Councilmember Cunningham made a motion, seconded by Councilmember O'Connell, to close the public hearing. The motion was carried unanimously by all present.

### **NEW BUSINESS**

H. Consider Introduction of an Ordinance Conforming Sewer Service and Water Service Charges to Charges Approved by City Council on April 20, 2023

Finance Director Yuen reported that on the prior agenda item, Council adopted a resolution establishing revised sewer service and water service charges for the next five years. Staff is recommending Council now introduce an ordinance conforming provisions in the Brisbane Municipal Code to the charges Council approved in the resolution including an annual 9% increase of 9% through fiscal year 2027/2028 in the fixed water charge, an annual increase of 7% through fiscal year 2027/2028 in the water usage rate, a 25% annual increase through 2027/2028 in sewer service charge, and setting the discount rate for the City's Low income Rate Assistance Plan at 25% for all services.

She added that under the Ordinance, Council may by resolution reduce or cancel the rate increase for any particular year without jeopardizing the approved rate increase for the following year. The Ordinance, if introduced this evening, will have a second reading on May 4 but the charges will not go into effect until June 15, 2023, consistent with the effective date of the new charges set forth in the resolution.

After no public comment, Councilmember O'Connell made a motion, seconded by Councilmember Cunningham, to introduce an Ordinance Conforming Sewer Service and Water Service Charges to Charges Approved by City Council on April 20, 2023. The motion was carried unanimously by all present.
