Recommendation

Approve the Brisbane Lions Club Fun Run & Pumpkin Patch application for a cosponsored event.

Background

The Brisbane Lions Club is a 501(c)(3) committed to serving the community. Lions Clubs are spaces where individuals join together to give their time and effort to improving their communities, and the world. They help the community get vision and hearing care and equipment. They support the students in the community through the scholarship program and provide opportunities for scholarships to any college enrolled student who lives in Brisbane.

Discussion

The Fun Run & Pumpkin Patch will be held on Saturday, October 18th, 2025, from 9:00am-2:00pm at the Brisbane Community Park Gazebo, Picnic Areas 1,2,3, and Lawn Areas 1,2. The event is a pumpkin patch and a check in area for the fun run along with a BBQ. The Brisbane Lions Club qualifies under the Group II category for use permits as a non-profit group serving the Brisbane community. Meeting the Group II requirements with the events open to the general public qualifies them for free use of the facility and waives the deposit requirement.

The Brisbane Lions Club is requesting support from the City as summarized in the table below. Use of the facility and the deposit are waived as part of their Group II designation.
