Dear Council Members,

We request reimbursement in the amount of \$300 for the repairs to the damage done to our house at 283 Wood Street, Bristol on Sunday and Monday, July 12 and 13, 2026 by a town tree that had grown over our property. On July 12, 2026, I requested, via online submission as well as an in-person visit to the DPW, that the large branch on the peak of the roof of our house be removed. The wind increased the evening of July 12, so I called again the morning of July 13th to inform the DPW that the branch was moving across the top peak of the front of the building and causing even more damage. With much appreciation, the branch was removed on Tuesday, July 13th.

Given that a portion of the roof was torn off and exposed the wood underneath, I requested that Ferschke Construction, LLC do the work as quickly as possible, so we didn't suffer more damage if there were any rain to get into the house where the shingles had been torn off by the tree branch.

The cost to us to repair the roof and fascia was \$300. Receipt for this work is attached.

We thank the Town for their swift attention and removal of this branch and request that the Town reimburse us for the damage done by a tree on Town property that was not adequately trimmed to prevent such damage.

NARRATIVE

On 07/15/2026 at approximately 1116 hours, I responded to Bristol Police Headquarters to speak with a complainant. Upon my arrival to Police Headquarters lobby, I was met with Glenn Bouchie [REDACTED] who wished to report damage to the roof of his residence.

Bouchie stated that on 07/12/2026, he was at his property at 283 Wood St. Bouchie was cleaning up brush that had fallen from a town owned tree located adjacent to his residence. Bouchie advised that numerous branches and debris had accumulated on the front porch area. While Bouchie was removing the brush he observed a large tree branch leaning against the east side of the residence.

Bouchie noticed that the branch had struck the roof, causing minor damage. Bouchie pointed out a small section of the roof where the impact had chipped out the shingles. Bouchie showed me a photograph of the damage, and I observed a small chip on the corner of the roof, located on the east side. After Bouchie observed the damage, he contacted Department Public Works (DPW) regarding the tree leaning on his residence. Bouchie stated the DPW employees responded to the residence and removed the tree.

Bouchie stated that he wished to have this matter documented. Bouche completed a hand-written witness statement and was advised to contact Police if any further issues arise.
