## **Bristol Harbor Inn- 6-month review of Dancing and Entertainment license:**

A review has been conducted of all calls for service for the establishment during the last 6 months. We have handled the following calls for service related to the Dance and Entertainment license:

- 06-01-2024 (Sat.)@ 2317 hours- Loud music playing (tent)-management advised
- 06-22-2024 (Sat.)@ 2109 hours- Loud music playing (tent)-management advised
- 07-13-2024 (Sat.)@ 2217 hours- Loud music playing (tent)-management advised
- 08-10-2024 (Sat.)@ 2236 hours- Loud music playing (tent)-management advised
- 09-01-2024 (Sun.)@ 2209 hours- Loud music playing(tent)-management advised

Current dance and entertainment license restrictions:

- Monday through Thursday until 10pm
- Friday through Saturday until 11pm

It should be noted that the music levels were determined to be within acceptable limits, and no further action was required. Additionally, officers responded to the tent venue on Sunday, 09-01-2024. I do not believe Bristol Harbor Inn is licensed for Sunday dance and entertainment activities. On Saturday 06-01-2024, officers observed that music was playing past 11pm. The petitioner should be made aware of all related calls for service. After conducting this review, the police department recommends approving this license provided that all laws and ordinances governing this practice are followed.
