I would like to make a request to extend my front driveway so I can park parallel to the street, on what is currently a grass area off the paved street.

I would like to do this for a few reasons, easier access to the front door, easier in and out of the car on level ground.

Please note there is no on street parking and an additional space would also allow my company a spot to park off the street.

I would need to do slight modification to level the incline a bit, tapering further back from within my yard area.

I would be laying in crushed stone to allow for proper drainage, and crushed shells over the stone. Same as current driveway areas.
Grass will be replanted if needed to be similar to current front yard.
