Bristol Middle Passage Port Marker Project will host the unveiling of the 3 figured sculptures on Sunday August 24th. We have applied for a permit with our Parks & Recreation dept. for that date. We request consent of the Council to allow us to host a 2-hour public event to celebrate the sculptures. This will be an alcohol free event. We are planning to have a speaker's program, some singing and dancing with the Pokanokets drumming and chanting. Right now, we are requesting use of the park for the full day for temporary setup of a tent with chairs to accommodate 100 people. Our event ceremony will be about 2 hours, likely from 4-6PM. The only amplification will be a microphone for the various speakers, perhaps six in all. We are still working out the details about the format. The setup will be broken down at the end of the event and we will clean up everything we are responsible for. We, the volunteer Board of Bristol Middle Passage would be honored by the attendance of our Town Council and the Administration. Thank you.

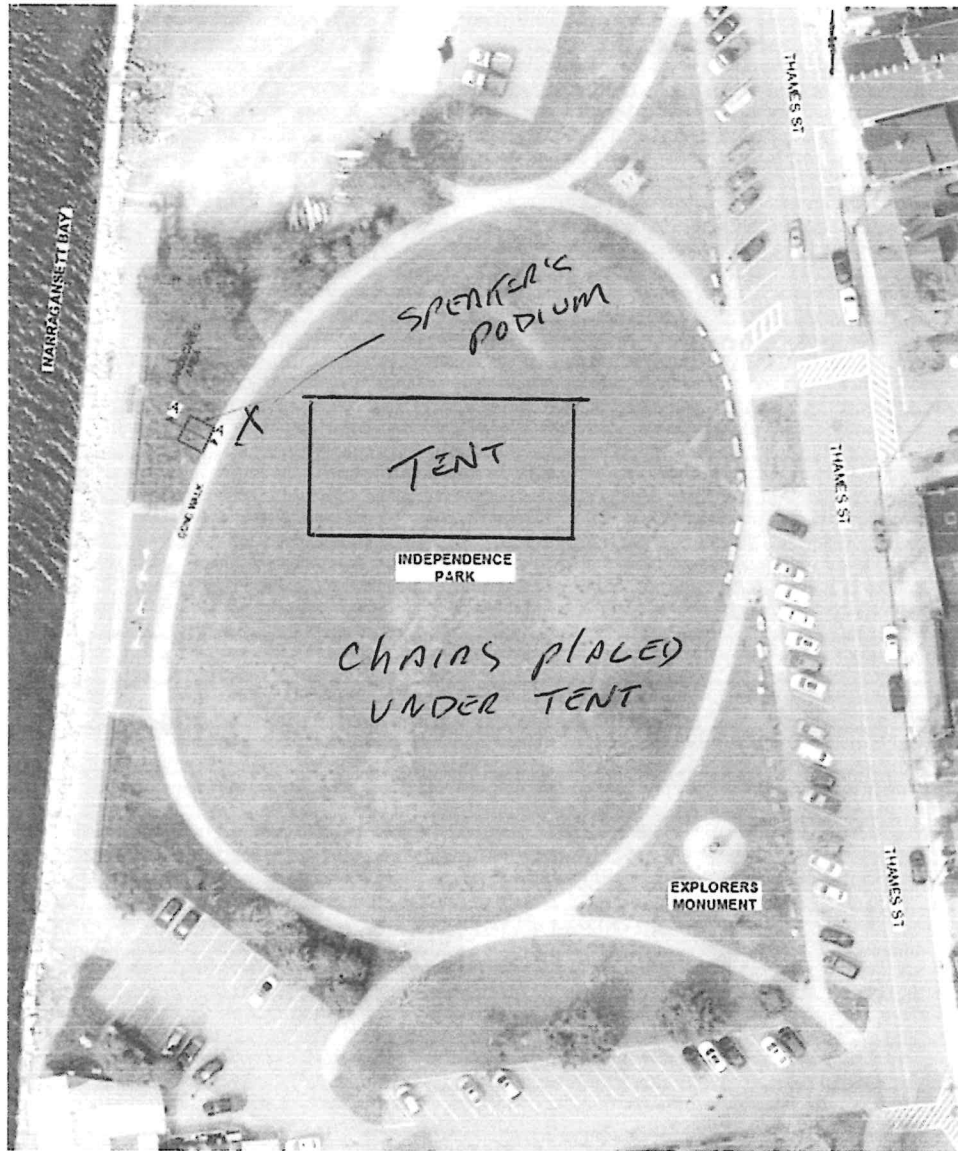
