Legal Terms

1. Project Description/Scope of Work

Please take special note of the job description. RM Painting is not required to perform any tasks not specified in the estimate.

2. Preparation

Interior:

- -RM Painting will cover all floors and furniture before painting.
- -Remove light switch covers and cover light fixtures with plastic
- -Cracks and defects in walls/ceilings will be patched prior to painting
- -All voids in trim will be sealed with caulking
- -Primer will be applied to all bare wood

Exterior:

-RM Painting will cover all necessary areas prior to painting (i.e. patios, plants, furniture, decks, etc.)

- -All surfaces will be scraped and sanded to remove peeling paint
- -Latex/Oil Primer will be applied on all bare wood

-All voids in trim will be sealed with caulking if trim is included in project scope

When the project is complete, all job sites will be cleaned prior to leaving.

3. Paint/Materials

-The estimate provided by RM Painting includes cost of paint and material only if specified in job description.

-Customers must choose colors prior to project commencement. Additional charges may apply if the customer changes colors after work begins.

-All surfaces will receive two (2) coats of paint (unless stated otherwise on estimate)

4. Unforeseen Conditions

-If any unforeseen repairs arise, customer will be notified and an additional work order will be written up for the customer to sign.

- 5. Customer Responsibility
- -The jobsite must be clean prior to our painters arriving
- -Wall hangings must be removed prior to project start
- -Work area must be free of other trades
- -The customer must be available on the last day of the project for a thorough walkthrough with crew lead.

6. Work Standard

7. Insurance

8. Warranty
