The Executive Director introduced Geoffrey Northup, who has been the Architect for the Housing Authority since the beginning of 2020. He reported that the garage addition project had been completed within the budget. The next project is replacing roofs which are leaking in the upper part of the Project which will be paid for from Capital Funds. The rest of the roofs will be replaced under the future Capital Funds. The bids for the current project are being worked on and should be awarded by Spring. After answering many questions from the Board, Mrs. Pansa thanked Mr. Northup for coming and answering all the Board's questions.

The Maintenance Supervisor then updated the Board on several issues. The annual inspections have been completed and repairs made as needed. Fire inspections are completed and stained ceilings will be taken care of soon. Thirty-three units have been turned over so far this year and handicap units are being rehabbed as standards have changed since the project was built. Commissioner Barboza asked what the turnover time for rehabbing units is. The Maintenance Supervisor explained that it depends on how much work needs to be done and the availability of products needed and availability of workers.



The Deputy Director presented the investment report for October and the snapshot of income and expenses for October and answered all the questions brought up by the Commissioners. The Board accepted the report.

The Executive Director reported that the Auditor would be coming next week for the annual audit. The Christmas party for the tenants will be a box lunch to be held on December 16^{th} .

The Chairman then introduced the following resolutions:
