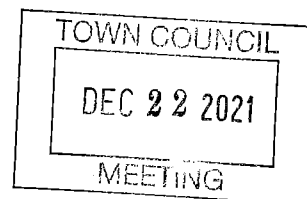

Sir,

Caroline Corrente is requesting a sidewalk use and alcohol service license for Roberto's restaurant to place five tables at the west side of the sidewalk, adjacent to Hope St. This is the location which was utilized for outdoor Covid dining relief.

I'm in agreement with Code Compliance Coordinator, Raymond Falcoa's findings that placing tables adjacent to Hope St. could cause an obstruction on a busy sidewalk.

I have reviewed this petition request and measured the sidewalk at the location. The sidewalk measures 17'6" building to sidewalk stone wall. There is sufficient room to place tables against the building. It should be noted that Roberto's under previous ownership has had a sidewalk use permit without any reported issues. Please refer to photos submitted with this memo.

There is no known reason for denial of this sidewalk use and alcohol service license for Richard and Caroline Corrente provided that all Law and Town Ordinances governing this practice are followed.

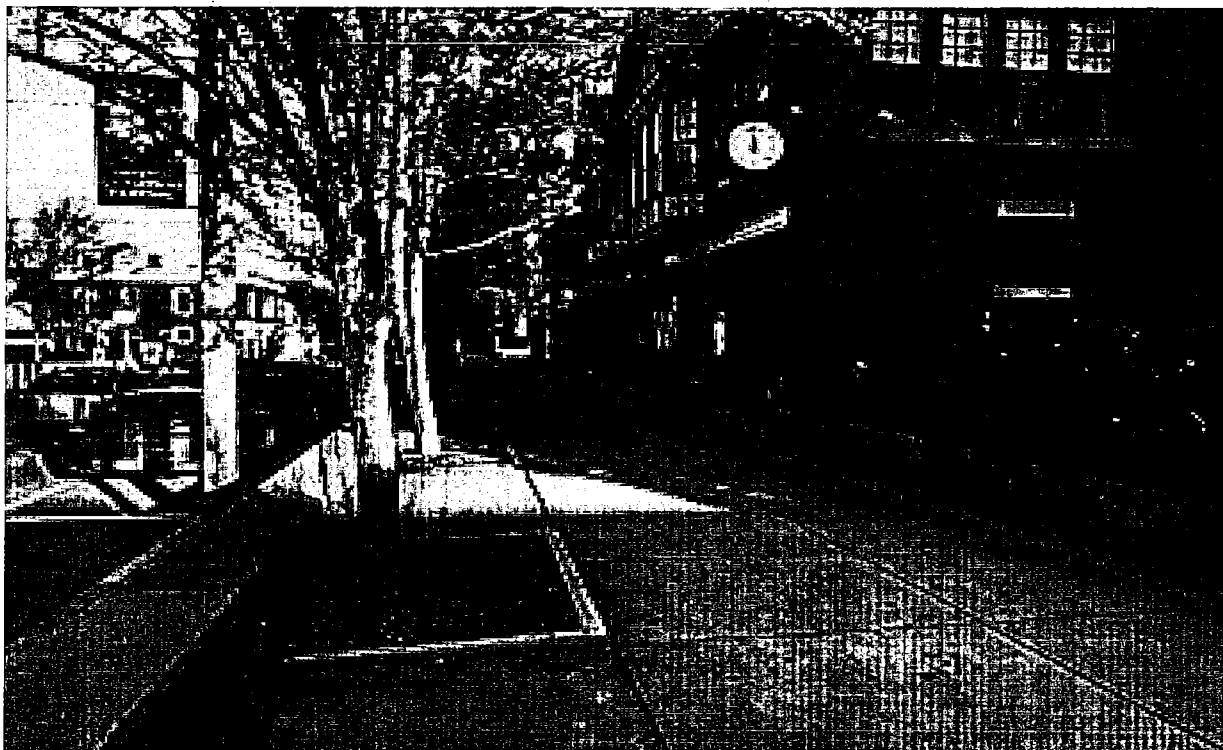
