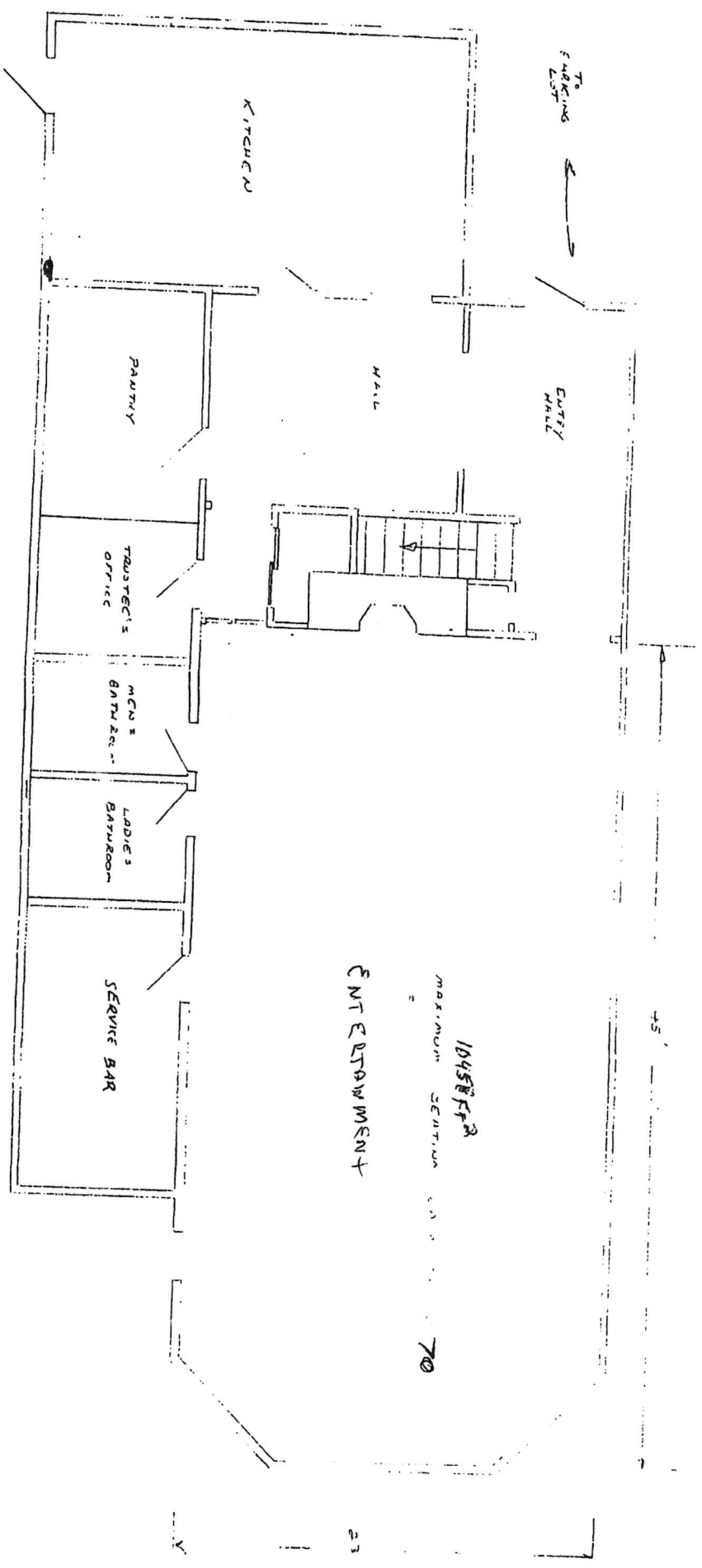

FIRST FLOOR PLAN

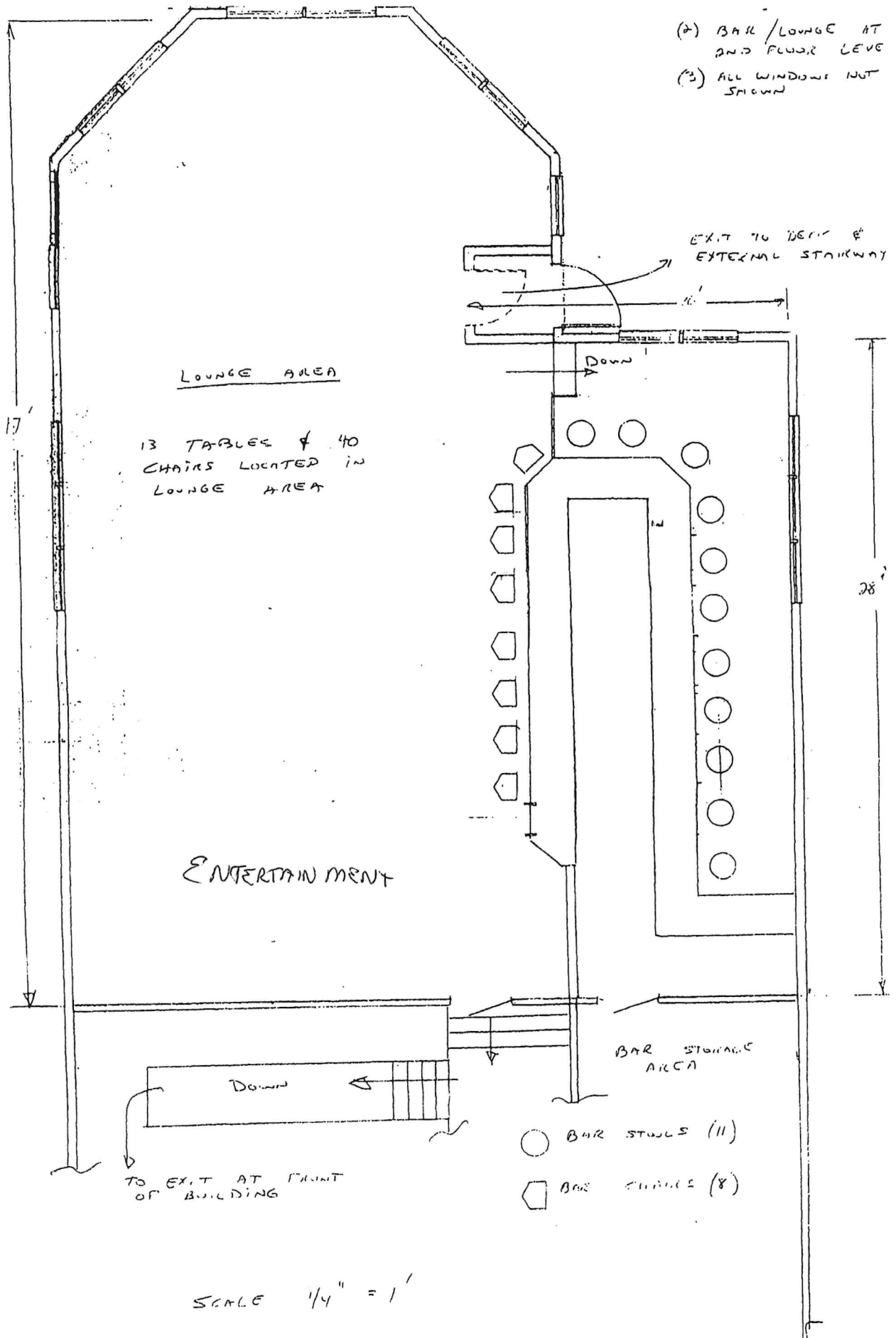
