

**MINUTES OF A MEETING OF THE
TOWN OF BRISTOL HOUSING AUTHORITY**

A meeting of the Board of Commissioners of the Town of Bristol Housing Authority was held on October 9, 2025. The Chairman called the meeting to order at 10:05 a.m. and upon roll call those answering Present were as follows:

The Chairman led in reciting the Pledge of Allegiance.

Thereupon, the Chairman declared the motion to accept the minutes as approved.

The Maintenance Supervisor reported on units rehabbed and three more were being worked on. Ground work has been completed and the staff is ready for the upcoming winter months. Apartment inspections have been completed and any findings have been addressed. It was suggested that the maintenance staff take a class on the NSPIRE inspections.

The Executive Director reported that work on the shower project will be starting soon and that the grant for having internet service for tenants is still up in the air.

The Deputy Director presented the investment reports and snapshot of income and expenses for September.

Mrs. Pansa informed the Board that she has set up the audit to be done on November 12th and 13th. She has also sent a list of upcoming meetings to the state and has scheduled fire alarm inspections.

The Chairman then introduced the following resolution:
