SUBJECT : HOPEWORTH AVE. TRAFFIC STUDY

Sir,

In reviewing this Traffic Calming request for Hopeworth Avenue, we conducted a one-week bidirectional traffic study. For this analysis, we utilized a utility pole-mounted traffic collection device capable of capturing bidirectional data. The data collected includes the number of vehicles traveling in each direction as well as their respective speeds. The list below will show the data obtained during this study:

Furthermore, we conducted a comprehensive review of all motor vehicle collisions, traffic enforcement posts, and motor vehicle stops. The list below will show the data obtained during this analysis:

After a thorough review of the collected data at the conclusion of our study, we determined that 85th percentile speeds in this area exceed the posted speed limit of 25mph. Despite regular traffic enforcement efforts at this location, the 85th percentile speeds remain at 8mph over the posted speed limit with violations occurring during both daytime and nighttime hours.

Noting our findings, we recommend considering the implementation of additional traffic calming measures. The Bristol Police Department supports the approval of this request to proceed to the next step and we will continue with traffic enforcement
