not any signs.

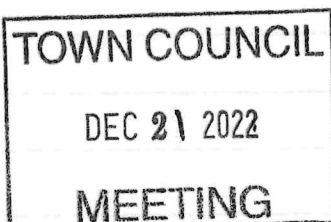

On 10/28/22 at approximately 1006 hours, Austin Davis ([REDACTED]) responded to Police Headquarters to report past damage to his vehicle. I spoke with Davis in the lobby of HQ.

Davis advised on 10/19/22 at approximately 2230 hours, while traveling east on Mt Hope Ave at Fox Hill Rd, the driver's side front tire to his vehicle was punctured while traveling through the construction site. Davis stated there were no visible signage at the time of the incident. Davis stated there was no other damage to his vehicle due to the incident and he has already replaced the tire. Davis stated when he responded to the Town Hall in the attempt for reimbursement of the tire he was directed to file a Police report first.

I observed Davis's vehicle, a blue Toyota bearing RI passenger registration PJ290. The vehicle had a new driver's side tire. No other damage was observed.

Mt Hope Ave at Fox Hill Rd has been under road construction for several weeks, however I could not determine if tire was damaged from the condition of the road at that time.

Davis was advised a report would be placed on file.
