THAMES WATERSIDE UPSTAIRS FLOOR PLAN



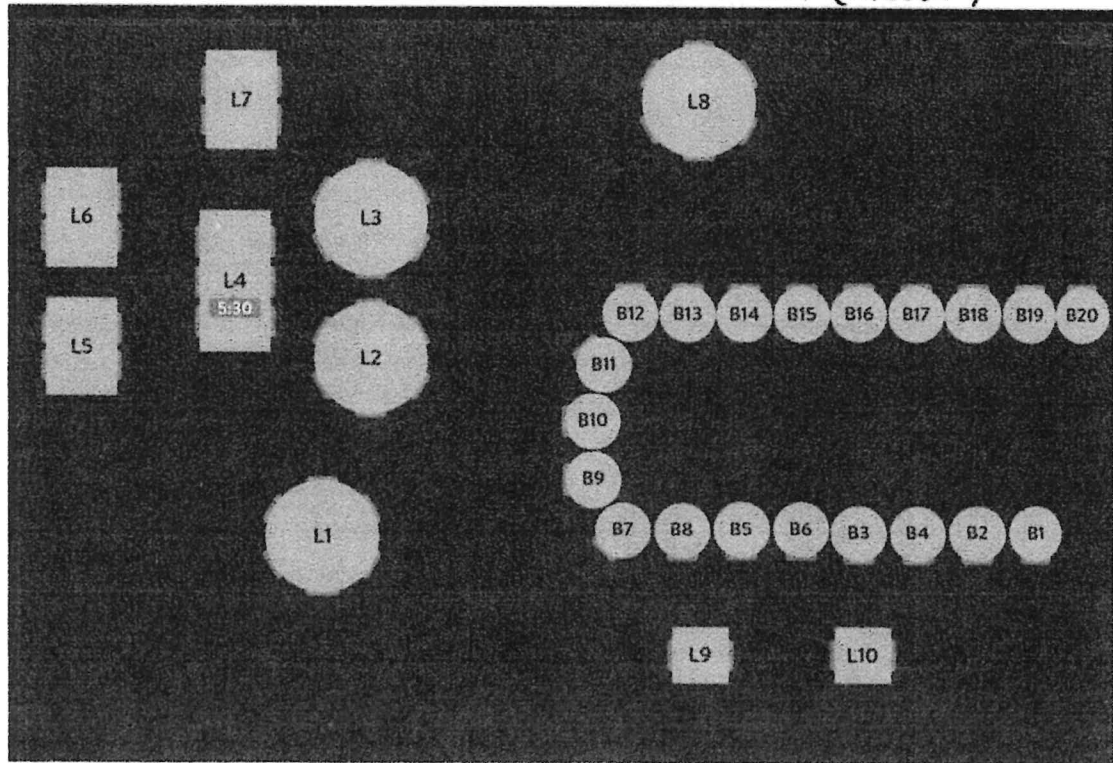

FLOOR PLAN: COCKTAIL HOUR



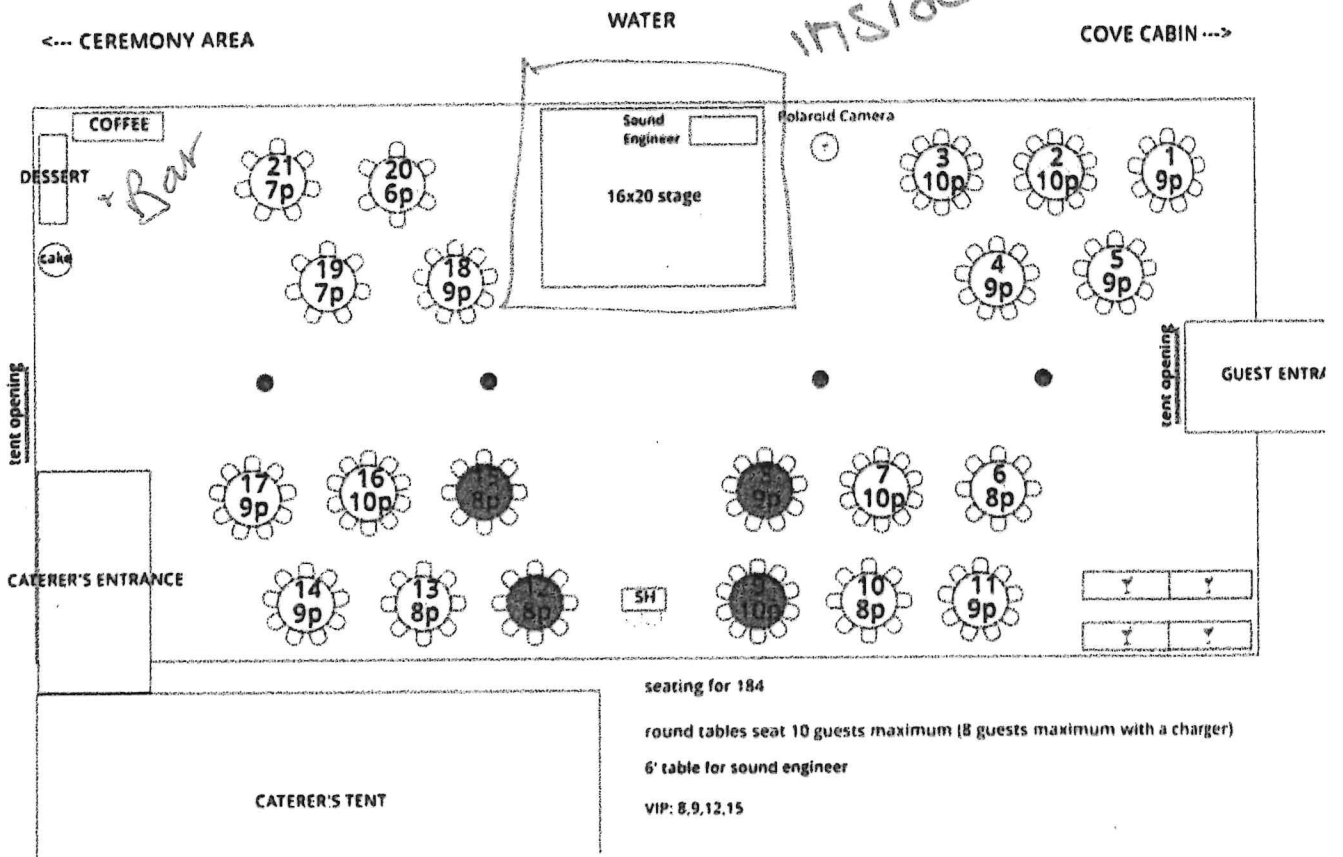

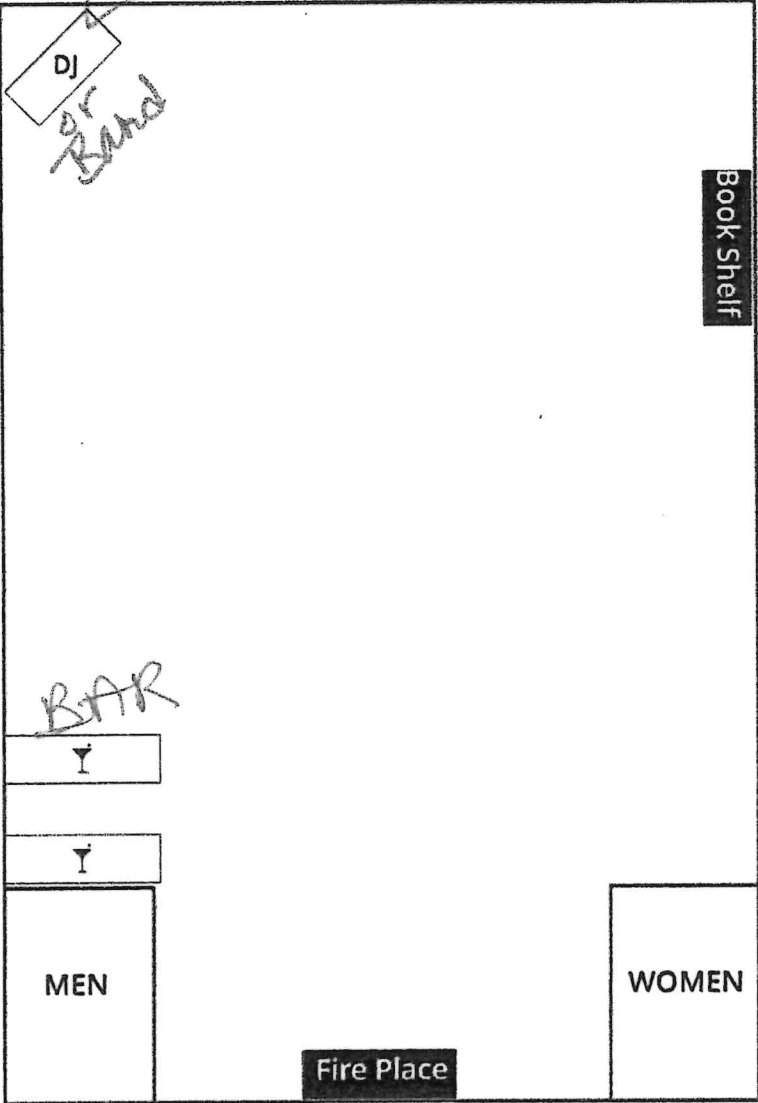
