NARRATIVE / GIST

On 5/12/26 at approximately 1648 hours, James Wright [REDACTED] responded to Police Headquarters to file past property damage report. I spoke with Wright in the lobby of HQ.

Wright stated on 4/22/26 at approximately 2330 hours while traveling on Hamlet Court he struck a pothole causing damage to his passenger side front tire on his Red Buick, bearing RI registration XZ822. Wright advised he placed his spare tire on the vehicle that evening and the next day (4/23/26) he had the tire replaced at Town Fair Tire in Middletown. No other damage to his vehicle was reported. Wright provided me a receipt from Town Fair Tire totaling \$366.46. Wright advised he contacted DWP who since have repaired the pothole on Hamlet Court.
