



**TAP ROOM:**


- Capacity 86
- Entertainment is on the tap room floor.
- No staging or dance floor.
- Entertainment Area is located 30 feet from the main entrance.
- An additional entrance/exit is adjacent to the entertainment area.

**OUTDOOR:**

- Outdoor space is non restricted.
- 70 feet of fence runs along the southern property line on Shannon Ct to limit access to the road.
- There is no fencing or barriers to the East and West allowing access/egress in event of emergency.

**ENTERTAINMENT AREAS:**

- On occasion there may be a stage brought in for outdoor entertainment in the summer.




