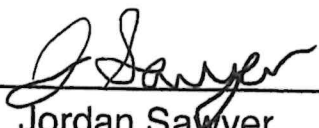

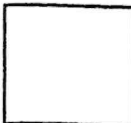

We are proposing an amendment to:

Sec. 17-82. Number of licenses.

(4) For B-V, there shall be a maximum of 32 licenses.

a. The establishment granted this license must close every day no later than 11:00 p.m. Any establishment that has a pre-existing license that allows a closing time later than 11:00 p.m., and wishes to maintain such later closing time, shall remain subject to all previous conditions, including without limitation, with regard to service of food during all of the time that alcohol is being served....

This amendment is to allow establishments with new liquor licenses to be eligible to request a later closing time on or after the review performed by the council six months from the date of issuance (stated in paragraph (f.))

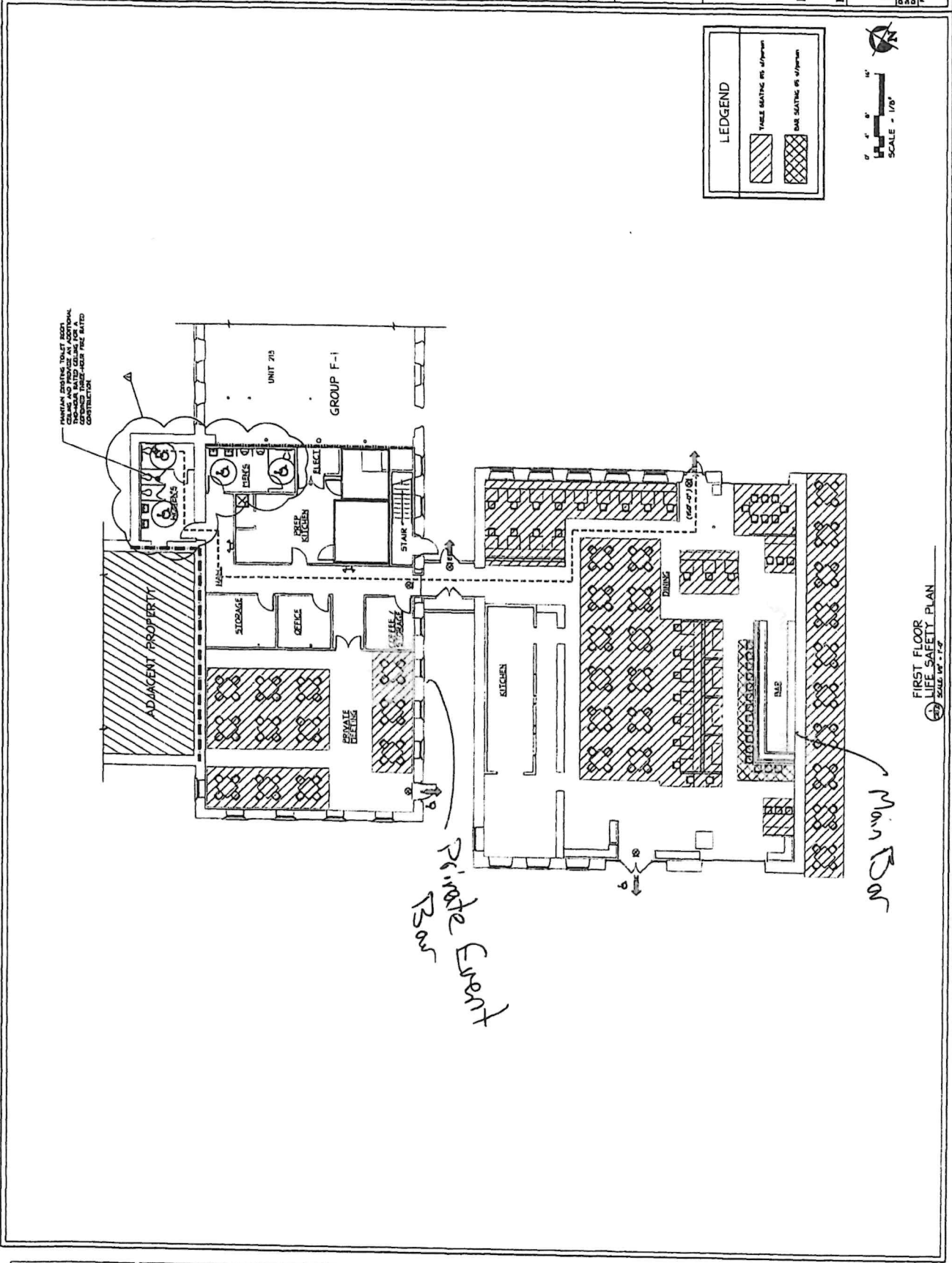

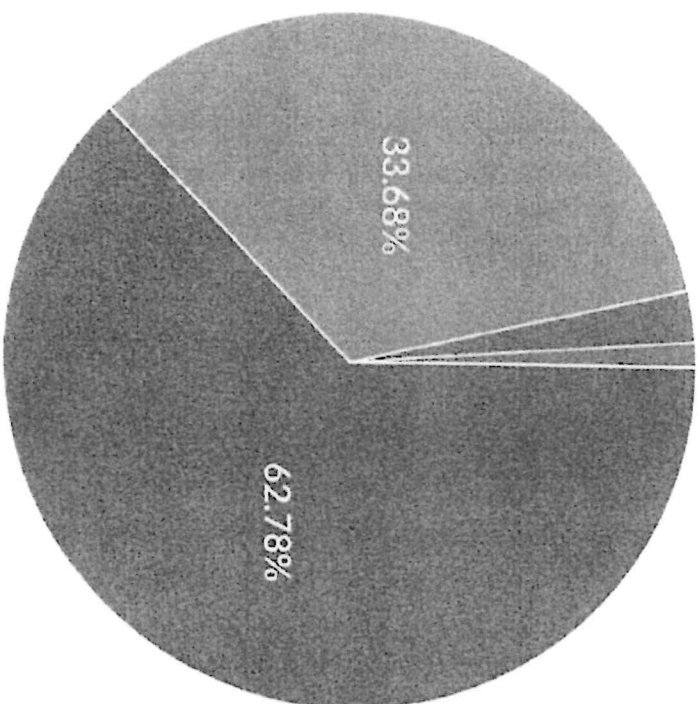
