#### **AGENDA ITEMS**

## 1. CALL TO ORDER/ATTENDANCE/QUORUM

Al Wroblewski called the meeting to order at 6:35pm and noted there was a quorum. Clarification regarding majority vote given current number of Trustees on the board: 6 members present requires 4 votes, 5 members present requires 3 votes, 4 members present requires 3 votes.

Beverly made a motion to move Al's talking stick points to Member Perogeratives. Motion seconded by Samantha Faria. Vote: all in favor, motion passes.

## 2. REVIEW/AMEND/APPROVE MINUTES OF PREVIOUS MEETING

Minutes of February 16, 2023

 Beverly Larson noted an error in the minutes - minutes should reflect election of officers in June with a start date in July.

 Marie Knapman makes a motion to approve the minutes with amended language for election of officers in June. Motion seconded by Beverly. Vote: all in favor, motion passes.

#### 3. CHAIR REPORT

Al will be writing a Chair report for the monthly meetings. Al has continued to meet with Dawn once a week to stay connected.

### 4. LIBRARY DIRECTOR REPORT

The Ron Jones program was excellent - heard from members of the 4th of July Committee. Due to ongoing behavior issues in the Teen Room, the Teen Room now closes at 7:30pm. Marie inquires about the snow day complaint; Dawn stated that a complex formula is used to make the decision. Part of the parking lot is used for community parking when a parking ban is in place and usually needs to close during a parking ban. The library often follows the school closings, delays, etc.

## 5. FINANCIAL REPORT

When Dawn is in Accufund accounting system and you see Fees and Fines - we don't collect fees/ fines anymore except for printing.

Request is for 3% increase for all FTE - assistant director salary will be \$55,000.

OSL recommends we increase contribution for eBooks to \$12,000 but we have funding from Friends to establish our own eBook collection.

This year there is a \$9,000 decrease in our budget because state aid has gone up \$30,000 - Dawn is putting that \$30,000 back into salaries.

The Town of Bristol doesn't fund children's books/collection or any programming - both are funded by the Friends of Rogers Free Library.

We again discussed that the Thomas Shepherd line still exists in our Financial Report; Dawn says if the line is still there at the end of April she will copy Trustees on correspondence with the town.

Water - Dawn put fire suppression in this line but it should be in building maintenance and will discuss in her meeting on Tuesday.

Natalie, RFL bookkeeper (8 hrs a week) and Dawn met with the Town Treasurer to go over and confirm salaries.

 Samantha Faria made a motion to rescind the Bylaws change, seconded by Beverly
Larson. Vote: all in favor. Revision to be reconsidered perhaps in July - 2020 was the last
revision.

### 8. NEW BUSINESS

- Library Grants
  - o Historic Digital Archive
    - This was a request from the Historical Society but is a collaborative project it would get the digital yearbooks off of Flipster, increase grant funding to include the BIPOC database and add a Bristol archives page to the RFL website. RWU is currently in charge of the Bristol Phoenix digitization archive. Preliminary discussion about the future of the digitization project.
- Trustee Selection Committee
  - o Marie Knapman, Chair
    - at least 7 or 8 applicants
    - will meet after the meeting to discuss further steps
    - will check with Town Clerk about applicants and look for clarification on applicants who didn't submit a resume or cover letter
    - will interview all applicants
    - we will give the council a ranking of applicants
    - Trustee selection committee will also be the "oversight committee"
