NARRATIVE FOR PATROL OFFICER SEAN D GONSALVES

On 04/03/23 at approximately 0745 hours, I was dispatched to the lobby of Police Headquarters regarding a vandalism complaint. Upon my arrival, I spoke with the complainant William Henrich (1996), who advised that on friday evening (03/31/23), his wife was driving his vehicle, RI VF 16714 and struck a large pothole in the area of Wood St in between Bradford St and State St.

Henrich advised that the pothole was a result of the milled road that is awaiting pavement and requested the incident be documented so he could be reimbursed. Henrich advised that the following day he discovered the tire in question, the rear passenger tire, to be completely deflated with damage to the side wall. Henrich completed a hand written statement and was advised that a report would be generated documenting the incident.
