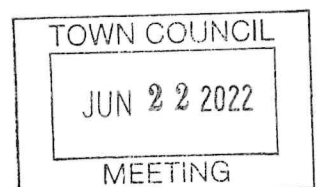


### **Re: Opioid Litigation – Year One Payment from Teva/Allergan Settlement**
