Dear Bristol Town Council:

I represent Joseph Nunes who resides at 85 Union Street, Apt. 7 in Bristol, Rhode Island with regard to injuries he sustained on May 15, 2022 at approximately 5:00 PM. Joseph Nunes was injured as a result of tripping and falling on the lip of a raised section of the sidewalk located in front of 244 Hope Street in Bristol, Rhode Island. This section of sidewalk is on the easterly side of Hope Street. The Bristol Police Department responded to the scene to assist Joseph Nunes and filed a report of the incident that includes the exact location, date and time of Joseph Nunes' injury and a summary of how Mr. Nunes was injured.

While walking north on the sidewalk in front of 244 Hope Street Mr. Nunes struck the front of his shoe on the raised section of concrete causing him to fall to the ground. The raised section of concrete is a dangerous hazard that caused Joseph Nunes to trip and fall to the sidewalk.

As a result of falling Joseph Nunes sustained bodily injuries including a fractured nose and lacerations to his face, hands, and arms. Mr. Nunes was taken by ambulance to Rhode Island Hospital from the scene to be treated for his injuries and is currently undergoing additional medical treatment for his injuries.
