Hello,

Attached are photos from my property at 9 Court Street parking lot and driveway on the East side and North side (behind the building). Now that the snow has melted, I see damage done by a plow to both the back and side of the building. The DPW plow hit my bulkhead door, bringing it up and damaging the flashing and boards underneath, and it now leaks. At the same time, they hit one of my condensers almost knocking it off the cement pad and crimping the line going into the building. In addition, one of my parking curbs in the lot was taken up off the rebar, and now I have rebar sticking up in my parking lot.

I hired someone to clear my lot each snowstorm, but when we arrived at the building the lot had already been cleared by DPW each time. My plow guy then just hand shoveled and did my walkway without plowing the driveway or parking area. I am assuming that the DPW did not know that 9 Court street is now privately owned and figured it still belongs to the town.
