### NARRATIVE / GIST

On 02/27/26 at approximately 1218 hours, I responded to 56 Court St for the report of property damage. Upon arrival, I met with the calling party identified as Paul Znamirovski (Dob: [REDACTED]). He stated that on 02/26/26 the town was conducting snow removal from the road and sidewalk in front of his residence. He stated that while removing the snow the front northeast corner of his residence was struck by heavy machinery. He stated that the machine had caused damage to the front decking and brick foundation of the residence. I observed the damage to the residence which was consistent with Znamirovski's claims.

Znamirovski advised me that he responded to Town Hall who advised him to place a report on file with the police department in regard to the incident. He stated that he was advised the matter would be taken up at the next town council meeting.
