On 07/23/25 at approximately 1434 hrs, Ptlw Gaffney and I received an online police report for damaged property.

William Low [REDACTED] advised police that a tree on Low Ln fell, damaging the gutter of his residence and side mirror of his vehicle (RI CO 1MW884) on 07/03/25.

At approximately 1515 hrs, I attempted to contact Low via phone but left a voice mail.

At approximately 1820 hrs, I spoke with Low, who stated that he had photographs of the damaged driver's side mirror and gutter. Along with the photographs of the damaged mirror and gutter, Low also included the quotes he received for the repairs. The paperwork indicated the mirror repair is \$113.39 and the gutter repair to be \$1100.00.
